This is a booklet giving testimonials about Partners in Policymaking.

Partners in Policymaking was created in Minnesota by the Governor's Council on Developmental Disabilities in 1987. *Partners* is an innovative, competency based leadership training program for adults with developmental disabilities and parents of young children with disabilities. The purpose of the program is twofold: To teach best practices in disability, and to teach the competencies of influencing and communication.

Since 1987, *Partners* programs have been implemented in 30 states funded by the Developmental Disabilities Assistance and Bill of Rights Act. More than 4,000 *Partners* graduates are part of a growing national network of community leaders serving on policymaking committees, commissions, and boards at local, state and national levels.

Documented program results show that *Partners* preserves families; and increases the independence, productivity, integration and inclusion of individuals with disabilities and their families into their communities. The value and success of the program, and the personal achievements of *Partners* graduates are evident in the testimonials that are contained in this booklet.

Arkansas:

We have had the opportunity to perform with the Naumburg Orchestra at Lincoln Center in New York City, but the performance we're most proud of is our involvement in Partners in Policymaking. Partners has directly affected our family's attitude toward and understanding of our son's abilities and capabilities. A long sought after communications breakthrough has occurred. The entire scope and mission of our lives have been changed by the Partners experience.

A fountain of information, an awareness that the rights of people with disabilities must be protected - this is what I learned from Partners. This will all be possible when the public is also informed.

Senate Bill 807 was passed because of the persistence of a Partners graduate. This law allows students to remain in school and graduate with their class even though they reach age 22 years.

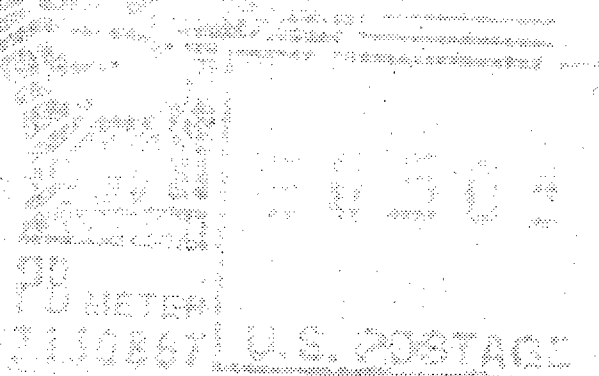
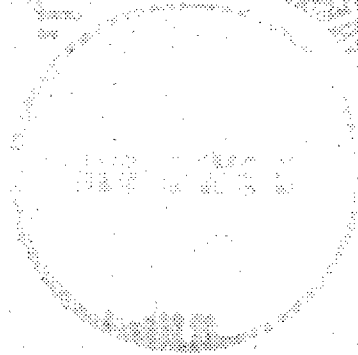
I have been in an institution for most of my life. I got myself a job at the local shopping mall. (He now works at one of his regular "hangout" stores).

Unfortunately, Delaware is one of those few states that does not have a statewide, comprehensive system of early intervention services. My three year old was not served by P.L. 99-457. I used to be angry that the parents before me did not advocate enough to get legislation passed, well now I am putting my anger to work.

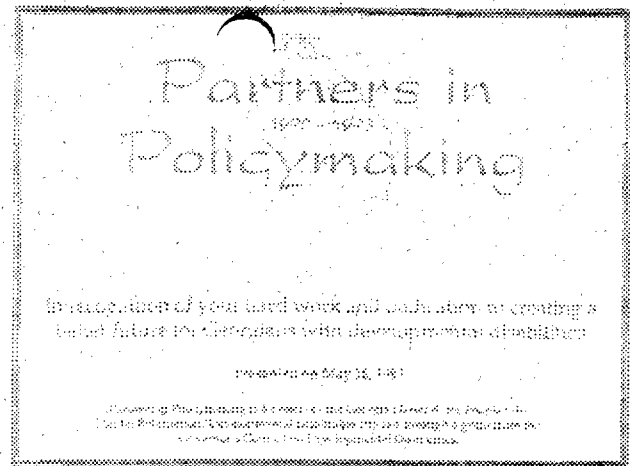

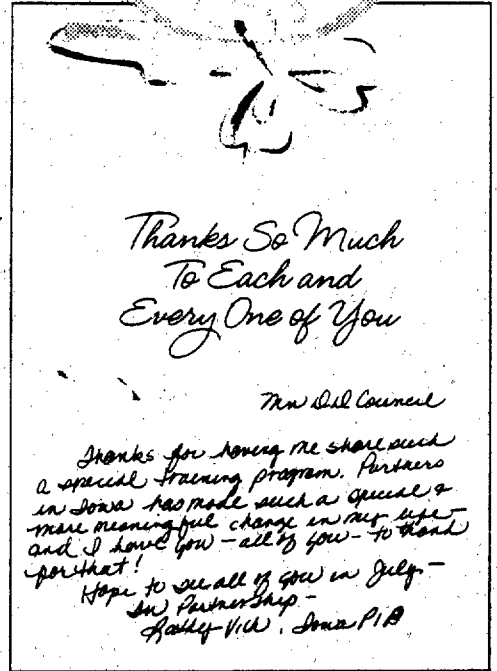

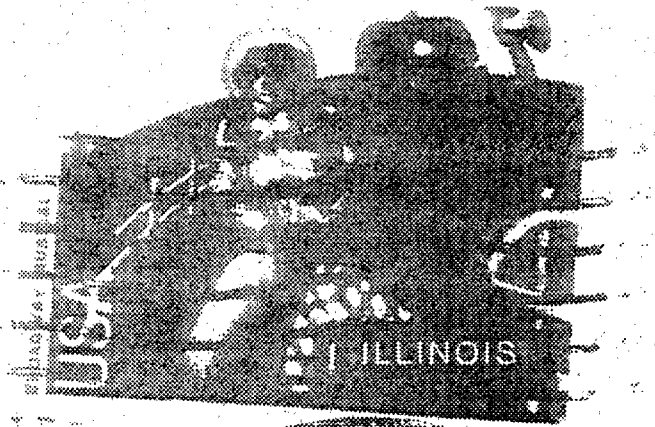
Partners strives to educate, enhance, and empower people.

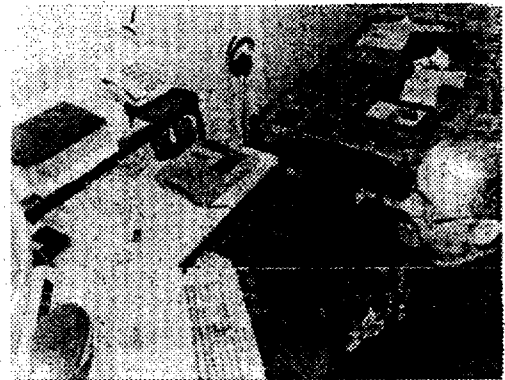
Medical considering new option

Dear Colleen:

The Summer Training Institute in Minnesota was wonderful! I wish all the LA 1991 Partners had been able to attend. It was such a rejuvenating experience. I truly believe that we need annual reunions to bring us up to date on legislation, new services, etc., and just to pump up our motivation! The faculty for the institute were very motivating. It was great to see Fran Smith, Ed Roberts and Sue Swenson again. Deborah McFadden is a wonderful speaker. We are indeed well represented in Washington.

My participation in Partners made me realize the importance of public awareness and understanding of persons with developmental disabilities. Prior to the movie "Rain Man", there was very little public awareness of Autism. My first goal after Partners was to enhance public awareness of autism and to increase my community's understanding of this developmental disability and therefore facilitate acceptance of persons with autism. The establishment of a local chapter of the Autism Society of America seemed a logical step to provide future support and resources for persons with autism in this area. Armed with knowledge gained through Partners and after several months of planning, I began my campaign to establish a local ASA chapter in February 1992. On May 4, 1992, with fourteen charter members, the Northeast Louisiana Chapter of the Autism Society of America became a reality. I now serve as president of this group.

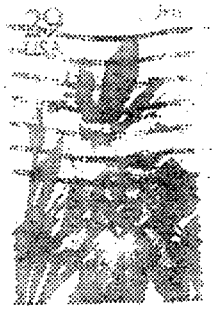
Shortly after completing my Partners training, I was invited to attend a parent training session by Project PROMPT (Parents Reaching Out - Model for Parent Training). As a result of this contact, I became involved in efforts to establish a state-wide network of family-directed resource centers, specifically for families of persons with developmental disabilities. It is the mission of this Family Resource Network to enable and empower Louisiana families of special needs through a coordinated network of resources, support, and information exchange. An experienced and informed family of a person with a developmental disability is an extremely valuable resource to the family of another person with a developmental disability. Such support and understanding are not available any where else. I am now serving as chairman of the Board of Directors for Families Helping Families of Northeast Louisiana, as our Region VIII resource center is now called.

Minnesota:

I find myself much more able to cope. I find myself looking long term and setting goals and priorities. "Fixing" Michael's academic problems which were so important one year ago are secondary now. More important is self concept, socialization, integration and independent living skills.

For me, being able to communicate with policymakers has diminished the underlying rage I have experienced for so many years due to my Anishinabe heritage.

If I could break down one barrier for people with disabilities, it would be other people's first impressions.



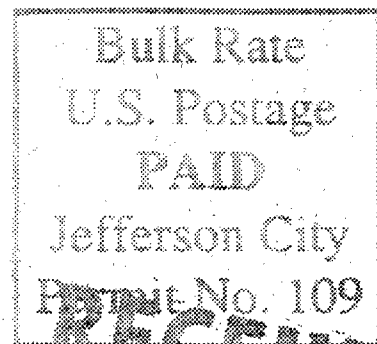

Montana:

Understanding the system, how to access the system in the appropriate way, how to affect positive policy changes - this knowledge will better prepare parents to properly make system changes and improve the quality of the lives of our children. Partners gave me unquestionable gains in my knowledge of the system, how to advocate for my two foster sons, and contribute to enhancing the opportunities for all individuals with disabilities to achieve independence.

At a time when everything in our personal lives seemed bleak and hopeless, and we lacked support and knowing how "the system" worked, Partners made it possible to regain some self-worth and patch up a pretty banged up self-esteem. I now have the tools to be effective in implementing our goals for our son, to change fear into opportunity and work within the systems to make decisions. Dare to dream...that Partners not only will make a difference, but is the difference.

Partners is an effective and powerful effort because it combines national and local expertise. Parents with their years of experience in the developmental disabilities system, coupled with Partners training, results in knowledgeable and focused leaders for our state.

Nebraska:

Partners was a big shock for me. I always felt isolation was better so people with disabilities wouldn't take teasing and abuse. I view individual plans differently.

My plan of action includes election to the Arc Board and developing closer contact with public officials.

I now have more control in my child's future in school and there's no reason not to speak out about concerns.



I didn't know Adult Basic Education was even possible for my daughter who is currently out of school, unemployed and not receiving any services. Partners taught me a lot, now my daughter has started classes and we both are feeling very hopeful.

New Hampshire:

I now feel confident to make informed and good decisions. I am not afraid of asking for help.

Our family is changing. We purchased a computer and added onto our house to give our son the privacy he needs.

I learned independence...I can talk for myself and not have someone talk for me. I have become aggressive and know when to use my power.

I am so much more informed, encouraged and strengthened.

A statewide telephone network was established after the first Leadership Series in 1988 and grows annually with each series. This network is activated whenever a political issue or information sharing is identified that may affect families or individuals with disabilities.

New Mexico:

I want to be a model for my seven year old daughter with cerebral palsy. I want her to know that she has a voice and should have the tools and self esteem to use it.

Partners are making changes in their communities. I don't feel powerless.

Self-advocates seek crosswalks with signals, a lengthened walk period, pedestrian over pass, or alternative signals for people who are blind when a friend with developmental disabilities was killed crossing a street.

NEW MEXICO - IT'S THE BEST OF BOTH

Diversity is important. Most of us now see that all people are people first with needs and rights. We all want to enjoy life, to feel productive and secure.

New York:

Partners are the national guard.

In 1991-1992, the family support budget was restored. Family support legislation was enacted. Partners are serving on the State Advisory Council.

Having a child with a severe disability was like having a grenade lobbed into the serenity of our family life. Everything in our life exploded. After one weekend of Partners, I came home and said, "We're going out to dinner." I didn't mind the stares because I'm a member of this great club united, strong, and working for changes.

In 1992, a Partners graduate wrote to Fisher Price to ask why children with disabilities weren't included in the catalog. The company responded by inviting her son for a photo shoot. Children with disabilities are now regularly featured in their catalogs.

Anastasia Somoza was a television star on February 20, 1993 when President Clinton met with 30 children from the United States. Anastasia was the only child to have a disability. She nearly moved President Clinton to tears as she explained how her sister uses a computer to communicate and she wants her to be in the same classroom. The New York City Public Schools have fought against inclusion.

North Carolina:

The program gave me a chance to learn more about disabilities and how I can improve the conditions in society by being a part of society. It made me feel important and it also gave me a greater sense of self-confidence.

When I think of a Partner, I think of someone who walks with you through thick and thin regardless of the situation.

Partners has opened my potential to be an informed, aggressive advocate for my family and community.

I learned about the different connections you can use to get things done. I enjoy talking to people with the same problems, working together so that things are less difficult.

Partners is an experience that has really changed my life! I feel much more in charge and more able to handle bureaucratic mumbo-jumbo. I am less intimidated by people in authority and I finally believe they are neither monsters nor superheroes, but just people in jobs where they may or may not be doing well. My job now is to keep track of how well they do concerning my interest.

North Dakota:

My son was totally isolated and didn't like school. Because of Partners, my son is the model of inclusion; he is happier and has more friends than I dreamed possible.

I received valuable information and inspiration needed to advocate for all people with disabilities.

The equivalent of a master's degree in disability and advocacy. Partners has challenged my perceptions and given me a clearer sense of direction.

I now feel differently about my child; it doesn't matter to me that he has a disability. I look at him as equal to others.

Thank you for the knowledge, experience, "fire," and compassion.

When I came to Partners, my daughter's education program was a mess. I could not understand why she didn't like school. After a few sessions, I learned how my daughter probably felt. I then learned what to do and how to do it. Partners has been the clear road to my daughter's success and happiness.

Ohio:

Thirteen families met with a U.S. House member to discuss health care reform.

We were named foster family of the year by our county. I have served on the state early intervention committee.

We designed a curriculum about disability awareness. The slide show depicts children and families who are differently abled. The impact has increased understanding among nurses, social workers, administrators, parents, and teachers.

Over the past year, Chris had spent a good part of his school day in regular classrooms and has begun to use facilitated communications with assistance from the school staff. Tested two years earlier, Chris scored a 28 on an I.Q. test. The latest evaluation, using facilitated communications, resulted in an estimated score of 133.

Pennsylvania:

I believe I will be able to participant in those areas of the movement that I have interest in more fully and also be able to listen to different view points without disdain.

I think I am more confident about how I present myself and my wishes. I'm not nervous about talking to politicians now. I also think I'm angrier, more militant, and less able to keep my mouth shut when I see inequities. Hopefully, I'll find a way to "use" my anger constructively.

I am now president of a Family Support Group.

I prepare and distribute a one page, three column newsletter, along with other pertinent information to a mailing list of over 50 families and over 15 others, including providers, interested professional, and educators. We have provided information to schools. I feel much more comfortable in writing or otherwise contacting legislators. I don't have to be an expert, attorney, or professional. My knowledge as a parent and advocate is valuable and I am a powerful and convincing spokesperson.

South Dakota:

One of the graduates lived in a group home. After graduation, she purchased her own home.

Partners attended a series of town meetings around the state. The state agency staff wanted to know if the coordinator had worked with one witness all day to prepare her. No, we didn't coach her. She's a Partners graduate.

I was doing piecework at a sheltered workshop. I decided to go back to school to become a secretary. The difference was self esteem. Partners saved my life. I used to be on psychotropic medication. I started asking questions, decided to say no and took control of my life.

Tennessee:

It's about having a vision and then finding ways to enact that vision in tangible outcomes.

Partners includes civics, confidence building, and grassroots radicalism.

My participation in the Partners program was a positive experience. This experience has raised the level of my involvement in both the legislative and community development arenas. The leadership training I received improved my ability to address the issues that people with disabilities face from the standpoint of an informed advocate.

Being a member of Partners in Policy-making has taught me that we who "know" can make a positive difference in the policies that affect us or our children. It turns the helpless, powerless feelings into knowledge, influence and change.

Izhtak Perlman, noted international violinist:

One has to separate one's abilities from one's disabilities. Some people looked on me as sweet, a human interest story, that's what I had to work to overcome. Even with all the regulations, accessibility at concert halls is still a crap shot.

I have enjoyed participating in the Partners class so very much, I am looking forward to putting my new knowledge to work. You have created a wonderful and necessary program that I am glad to have had the opportunity to attend and benefit from the fabulous resources, wisdom and information you presented.

I finally have wheels. After a wait of over 2 years I received an adapted car in September. I have a permit so now I will take lessons. Persistence pays off!

The information was invaluable. I now understand why it is so derogatory to use the "H" word.

After Partners, I was a changed person. I set to work on creating what was best for Rodney and our family. After some struggle, we got Rodney into a regular third grade class, he got help from staff and other kids. His behavior problems faded away quickly. It was then it dawned on me that Rodney had been bored with no role models. Now he is learning, taking part in school activities and making friends.

Utah:

I was given the opportunity to become a Partner and this outstanding program opened my eyes to the many different types of disabilities and disability issues. The training sessions and guest speakers provided an outlook of the necessity for people with disabilities to become active in changing and supporting programs and services that will improve their lives.

The Partners experience has provided me with sound knowledge about disabilities and how to give individuals with disabilities the ability to mature and change their lives and to enable the parents of children to support and meet the challenges facing them.

The time that I spent in Partner was wonderful. I was taught what services are available and how to utilize them. It has given me the confidence and knowledge to stand up for myself and others.

A year or so ago when someone asked me if I had Family Support, I thought they were asking if my parents or family members lived close by. Then I heard about Partners. I applied and what I learned changed my life and the life of my child forever. I now have a family support trainer that does community activities with my son weekly and also respite care so my husband and I have some time together.

Virginia:

I have been an advocate for my son for the past ten years; now I know how to do it right!

Partners has given me a road map to follow which has enabled me to successfully navigate through the system. I finally feel like I am in control, I have been empowered

The skills learned in Partners are life-long, and I am always going to need and use them. As a result of those skills, I successfully got my son into a summer parks and recreation program.

Washington:

The information I received gave me confidence to advocate for my daughter. Knowledge is a powerful tool.

I was determined to go back to school to receive my G.E.D. I have more confidence in asking and seeking what my girls need and deserve. I ran for the School Board and will try again this fall.

This was a once in a lifetime opportunity to receive an enormous education in a few weekends. It provided me with confidence, assurance, poise and determination that I too can make a difference for people with developmental disabilities.
