## **New User**

## **Copy**

Choose this command to create one or more new user accounts or one new group, copied from an existing user account or group that you have selected in the User Manager for Domains window.

## Delete

Choose this command to delete one or more user accounts, or one local group, that you have selected in the User Manager for Domains window. User accounts and groups that have been created using User Manager for Domains can be deleted, but the built-in user accounts and groups cannot.

Be certain you want to delete a group or user account before you do so, because they cannot be recovered. Internally, Windows NT knows every group and user account by its security identifier (SID), a unique number that identifies it. If you delete a group or user account and then create another with the same name, the new one will not have any of the rights or permissions that were previously granted to the old one, because they have different SID numbers.

## **Select Users**

Displays a dialog box from which you can select a group, and then quickly and easily select or deselect all the user accounts that are members of that group.

After the user accounts are selected, you can modify the properties of all those accounts in the same way, delete all those accounts, or create a new group containing those accounts.

This command is unavailable when Low Speed Connection is selected.

## **Select Domain**

When User Manager for Domains starts, it displays the domain where your user account is defined. Use the Select Domain command to display a different domain.

Optionally, use the Select Domain command to display an individual computer. However, you can only display a computer that maintains its own security database, such as a Windows NT workstation or a Microsoft LAN Manager server.

## **Account**

The Account policy controls how passwords must be used by all user accounts. It defines such things as the maximum password age, minimum password age, minimum password length, and whether or not a password history is maintained.

The Account policy also determines whether or not a remote user will be forcibly disconnected from all connections to servers in the domain if that user's logon hours expire.

## **User Rights**

The User Rights policy manages the rights granted to groups and user accounts.

A right authorizes a user to perform certain actions on the system. A user who logs on to an account to which the appropriate rights have been granted can carry out the corresponding actions. When a user does not have appropriate rights, Windows NT blocks attempts to carry out those actions. Rights apply to the system as a whole and are different from permissions, which apply to specific objects.

The rights granted to a group are provided to the members of that group. In most situations, the easiest way to provide rights to a user is to add that user's account to one of the built-in groups that already possesses the needed rights, rather than by administering the User Rights policy.

## **Audit**

Windows NT can track selected activities of users, by auditing security events and then placing entries in a computer's security log. Windows NT can record a range of security event types, from a system-wide event such as a user logging on, to an attempt by a user to read a specific file. Both successful and unsuccessful attempts to perform an action can be recorded.

Use the Audit policy to determine the types of security events Windows NT will log. When administering domains, the Audit policy affects the security logs of the domain controller and of all servers in the domain, because they share the same Audit policy. When administering a Windows NT workstation, this policy affects only the security log of that computer.

Entries in a security log can be reviewed using Event Viewer.

## **Trust Relationships**

The Trust Relationships policy is used to specify the domains that this domain trusts, and the domains that are allowed to trust this domain.

A trust relationship is a link between two Windows NT Advanced Server domains, where one domain honors the users of another domain, trusting the logon authentications performed by that other domain for its own users. User accounts and global groups defined in a trusted domain can be granted rights, resource permissions, and local group memberships at a trusting domain and its member computers, even though those accounts don't exist in the trusting domain's security database.

When trust relationships are properly established between all the domains of a network, they allow a user to have only one user account and one password in one domain, yet to access the entire network. Trust relationships move the convenience of centralized administration from the domain level to the network level.

Because trust relationships can only be established between Windows NT Advanced Server domains, the Trust Relationships command is unavailable when an individual computer (such as a Windows NT workstation) or another type of domain (such as a LAN Manager domain) is being administered.

## **Low Speed Connection**

When administering a domain or computer that communicates with your computer across a connection providing relatively low transmission rates, some User Manager for Domains functions may be performed slowly. This particularly affects the speed at which lists of user accounts, groups, or computers can be produced and displayed. In this situation, you can reduce delays by choosing Low Speed Connection from the Options menu.

The same option can also be selected (or cleared) from the Select Domain dialog box, at the same time you specify a domain or computer to be displayed by User Manager for Domains.

## **Confirmation**

Causes a message to appear asking for confirmation, after you issue certain commands.  
When Confirmation is enabled, a check appears on the menu to the left of the command.



## **Save Settings on Exit**

Saves these settings when you quit User Manager for Domains: Main window size and position, sort order (sort by user name or full name), and the setting for the Options menu Confirmation command.

When Save Settings is enabled, a check appears on the menu to the left of the command.

## The User Manager for Domains Window

In most cases, when User Manager for Domains first starts, it displays your logon domain. The title bar shows the domain name, and the body of the User Manager for Domains window displays two lists. The upper list contains user accounts; the lower list contains groups. One or more user accounts, or one group, can be selected and then managed using commands from the User menu.

**Title bar**

The title bar names the domain or computer that is displayed for administration.



## **Menu bar**

The menu bar contains five menus.

- User. Commands from this menu are used to create and manage user accounts and groups, and to select the domain or computer to be administered.
- View. Commands from this menu are used to sort the user account list either by user name or by full name, and to update User Manager with current information.
- Policies. Commands from this menu are used to manage the security policies.
- Options. Commands from this menu can select or clear the Low Speed Connection, Confirmation, and Save Settings on Exit options.
- Help. Commands from this menu provide online Help.


**List of users**


The upper half of the window lists the user accounts of the domain selected for administration (meaning the domain whose name appears in the title bar). The list contains both the built-in user accounts provided with the system, and any user accounts that have been added by using User Manager for Domains.

When an individual Windows NT workstation is selected for administration, the list contains the user accounts of that workstation.

## User icon

An icon graphically indicates the type of each listed user account.

 Global account. This is a normal user account in a user's home domain. Most accounts are global accounts. When trust relationships are established between domains, each network user only needs to have one global account in one domain, yet can be granted access to any trusting domain.

 Local account. This is an account provided in this domain as a special accommodation for a user whose global account is in a domain that does not have a trust relationship with this domain.

When an individual Windows NT workstation is selected for administration, the list contains only global accounts, because Windows NT workstations do not maintain local accounts.

**Username**

For each listed user account, this column contains a user name, which is used by Windows NT to identify the account. A user name is always unique, meaning it cannot be identical to any other user or group name of the domain or computer being administered.

The user names might be displayed in either the first or second column of the user account list. This sort order is controlled by commands which can be chosen from the View menu.

**Full Name**

For each listed user account, this column might contain the user's full name or it might be blank. (When a user account is created or modified, the full name is an optional entry.)

The full names might be displayed in either the first or second column of the user account list. This sort order is controlled by commands from the View menu.

**Description (of users)**

For each listed user account, this column might contain descriptive text or it might be blank.

(When a user account is created or modified, the description is an optional entry.)


## **List of groups**


The lower half of the window lists the groups of the domain selected for administration (meaning the domain whose name appears in the title bar). The list contains local and global groups, including both the built-in groups provided with the system, and any groups that have been added by using User Manager for Domains.

When an individual Windows NT workstation is selected for administration, the list contains only local groups, because Windows NT workstations do not maintain global groups.

## Group icon

An icon graphically indicates the type of each listed group.

 Local group. This type of group can only be granted permissions and rights for the servers of its own domain. However, it can contain user accounts and global groups both from its own domain and from trusted domains.

 Global group. This type of group can be granted permissions and rights for the servers of its own domain, workstations of its own domain, and for trusting domains. In all those places it can become a member of local groups. However, it can contain only user accounts from its own domain.

When an individual Windows NT workstation is selected for administration, the list contains only local groups, because Windows NT workstations do not maintain global groups.



## **Groups**

For each listed group, this column contains a group name, which is used by Windows NT to identify the group. A group name is always unique, meaning it cannot be identical to any other group or user name of the domain or computer being administered.

**Description (of groups)**

For each listed group, this column might contain descriptive text or it might be blank.  
(When a group is created or modified, the description is an optional entry.)

**Account policy**

## **Trust Relationships**

Trust Relationships specify the domains that this domain trusts, and the domains that are allowed to trust this domain.

A trust relationship is a link between two domains, where one domain honors the users of another domain, trusting that other domain to authenticate the logons of its own users. When trust relationships are properly established between the domains of a network, they allow a user to have only one user account in one domain, yet to access the entire network. All the computers on the network can recognize the user account, requiring a user to log on and provide a password only once to access any computer on the network.

Trust relationships move the convenience of centralized administration from the domain level to the network level.

## Selecting a Domain

When it first starts, User Manager for Domains displays the domain where your user account is defined. A different domain can be selected.

### To change the displayed domain

1. From the User menu, choose Select Domain.
2. Choose a domain from the list in the Select Domain box, or type a *domainname* in the Domain box.

Optionally, you can display an individual computer by providing the `\\computername` (precede computer names with two backslashes) in place of the *domainname*. You can only display a computer that maintains its own security database, such as a Windows NT workstation.

3. If the domain or computer you have specified communicates with your computer over a low speed connection, select the Low Speed Connection option.

The system saves the setting of this option for each of the last 20 domains or computers you have administered. After you specify a domain or computer name, the previous setting of this option (if any) is initially displayed here. If no previous setting is known, the option is initially cleared. You can accept or change the setting.

4. Choose the OK button.

## **Sorting the User Account List**

The user account list in the upper half of the User Manager for Domains window is sorted alphabetically by either the full names or user names of the user accounts.

### **To change the sort order**

- ▶ From the View menu, choose either Sort By Full Name or Sort By Username.

Note: When Low Speed Connection is selected, the Sort By Full Name and Sort By Username commands are unavailable.

## **Refreshing the View**

When User Manager for Domains first displays a domain or a computer, it obtains the information shown in the User Manager for Domains window. This information is automatically updated at fixed intervals. However, if you want to make sure the displayed information is current, you can use the Refresh command.

### **To update the view with current information**

- ▶ From the View menu, choose Refresh.  
Note: When Low Speed Connection is selected, the Refresh command is unavailable.

## Using Low Speed Connection

When administering a domain or computer that communicates with your computer across a connection providing relatively low transmission rates, some User Manager for Domains functions may be performed slowly. This particularly affects the speed at which lists of user accounts, groups, or computers can be produced and displayed. In this situation, you can reduce delays by selecting Low Speed Connection, which causes the following changes to User Manager for Domains:

- The list of user accounts does not appear in the User Manager for Domains window, and on the User menu the Select Users command is unavailable. However, user accounts can still be created or managed by choosing the New User, Copy, Delete, Rename, or Properties command from the User menu.
- The list of groups does not appear in the User Manager for Domains window. Local groups can still be created and managed by choosing the New Local Group, Copy, Delete, or Properties command from the User menu.  
Global groups cannot be created or copied, properties of existing global groups cannot be managed, and on the User menu the New Global Group command is unavailable. However, global group memberships can still be managed indirectly, by managing the group memberships of individual user accounts.
- The View menu commands (Sort By Full Name, Sort By Username, and Refresh) are unavailable.

Here are two ways to select or clear Low Speed Connection:

- When you have chosen the Select Domain command from the User menu and you are specifying a domain or computer that will be displayed by User Manager for Domains, in the Select Domain dialog box you can select or clear the Low Speed Connection option.
- When a domain or computer is already displayed by User Manager for Domains, you can select or clear this option by choosing Low Speed Connection from the Options menu.

The system saves the setting of the Low Speed Connection option for each of the last 20 domains or computers you have administered. After you specify a domain or computer name in the Select Domain dialog box, the previous state of this option (if any) will be initially set. You can accept or change this setting.

If you have not previously administered the specified domain or computer, and if you do not select the Low Speed Connection option in the Select Domain dialog box, after you choose the OK button the system automatically determines the appropriate connection mode and selects or clears the Low Speed Connection option accordingly. After connection, you still have the option of changing the setting by using the Low Speed Connection command from the Options menu.

Also, when starting User Manager for Domains from the command prompt you can optionally append the low speed connection parameter **[/l]** or the normal (high speed) connection parameter **[/h]**. For example, to start User Manager for Domains and administer a domain named Shipping using Low Speed Connection, you would type **usrmgr shipping /l**.

2. In the Username box, type a user name of up to 20 characters. A user name cannot be identical to any other user or group name of the domain or computer being administered. It can contain any uppercase or lowercase characters except for the following:

3. In the Full Name box, type the user's complete name.
4. In the Description box, type a description of the user or the user account.
5. In both the Password and Confirm Password boxes, type a password of up to 14 characters.  
  
Remember, passwords are case sensitive. (Windows NT distinguishes between uppercase and lowercase characters in passwords.)
6. Select or clear the Account Disabled option, and the password options.
7. To administer a property associated with one of the buttons at the bottom of the User Properties dialog box, choose one of those buttons and complete the dialog box that appears.

When administering a domain, there are five buttons: Groups, Profile, Hours, Logon From, and Account. When administering a workstation, only the Groups and Profile buttons are appear.

8. Choose the Add button.

The user account is added and the New User dialog box reverts to its default settings.

9. To add another user account, repeat steps 2 through 8. When you finish creating new user accounts, choose the Close button.

## Copying a User Account

In many situations, it may be quicker and more convenient to copy an existing user account than it would be to create an entirely new one. One major benefit of copying a user account is that group memberships are copied to the new account.

### To copy a user account

1. In the User Manager for Domains window, select a user account.
2. From the User menu, choose Copy.
3. In the Username box, type a user name of up to 20 characters. A user name cannot be identical to any other user or group name of the domain or computer being administered. It can contain any uppercase or lowercase characters except for the following:

" / \ [ ] : ; | = , + \* ? < >

4. In the Full Name box, type the user's complete name.
5. Optionally, to change the description, type new text in the Description box.
6. In both the Password and Confirm Password boxes, type a password of up to 14 characters.

Remember, passwords are case sensitive. (Windows NT distinguishes between uppercase and lowercase characters in passwords.)

7. Select or clear the Account Disabled option, and the password options.
8. To administer a property associated with one of the buttons at the bottom of the User Properties dialog box, choose one of those buttons and complete the dialog box that appears.

When administering a domain, there are five buttons: Groups, Profile, Hours, Logon From, and Account. When administering a workstation, only the Groups and Profile buttons are appear.

9. Choose the Add button.

The user account is added. The Copy Of dialog box reverts to its original settings.

10. To add another user account, repeat steps 3 through 9. When you finish creating copies of the selected account, choose the Close button.

## Managing Properties for One User Account

6. Choose the OK button.

## Managing Properties for Multiple User Accounts

The advantage of modifying multiple user accounts is that you can make the same change simultaneously to several accounts.

### To modify two or more user accounts in the same way

1. In the User Manager for Domains window, select two or more user accounts.
2. From the User menu, choose Properties.
3. To change the Description for all the selected user accounts, type new text in that box.

If all the selected user accounts have an identical description, that text is displayed. If one or more of the accounts have a different description, the Description box is empty.

4. To change the settings of the Account Disabled or password options for all the selected user accounts, select or clear those check boxes.

If all the accounts have the same setting for an option, the setting for that check box is displayed. If one or more of the accounts have a different setting for an option, that check box is indeterminate (filled with gray).

5. To administer a property associated with one of the buttons at the bottom of the User Properties dialog box, choose one of those buttons and complete the dialog box that appears.

When administering a domain, there are five buttons: Groups, Profile, Hours, Logon From, and Account. When administering a workstation, only the Groups and Profile buttons are appear.

6. Choose the OK button.

Any changes you have made are applied to all the selected user accounts.

## **Managing Group Memberships for One User Account**

Use the Group Memberships dialog box to manage the memberships the selected user account has in the groups of the domain or computer being administered.

### **To manage group memberships when only one user account is selected**

1. Choose the Groups button from the New User, Copy Of, or User Properties dialog box.
2. To add the user account to one or more groups, select one or more groups in the Not Member Of box, and then choose the Add button. Or, select one or more groups in the Not Member Of box, and then drag one of the selected group icons into the Member Of box.
3. To remove the user account from one or more groups, select one or more groups in the Member Of box, and then choose the Remove button. Or, select one or more groups in the Member Of box, and then drag one of the selected group icons into the Not Member Of box.

You cannot remove the primary group.

4. To change the user account's primary group, select one global group from the Member Of box, and then choose the Set button.
5. Choose the OK button.



## Managing Group Memberships for Multiple User Accounts

When two or more user accounts are selected, use the Group Memberships dialog box to add all the selected user accounts to one or more groups of this domain or workstation, or to remove all the selected user accounts from one or more groups of this domain or workstation.

### To manage common group memberships for two or more user accounts

1. In the User Manager window, select two or more user accounts, and then choose Properties from the User menu.
2. In the User Properties dialog box, choose the Groups button.
3. To add all the user accounts to one or more groups, select one or more groups in the Not All Are Members Of box, and then choose the Add button. Or, select one or more groups in the Not All Are Members Of box, and then drag one of the selected group icons into the All Are Members Of box.
4. To remove all the user accounts from one or more groups, select one or more groups in the All Are Members Of box, and then choose the Remove button. Or, select one or more groups in the All Are Members Of box, and then drag one of the selected group icons into the Not All Are Members Of box.

If even one of the selected user accounts is not a member of a particular group, that group is listed in the Not All Are Members Of box.

You cannot remove a primary group.

5. To change the primary group for all the selected user accounts, select one global group from the All Are Members Of box, and then choose the Set button.
6. Choose the OK button.

## Managing Profiles

Use the User Environment Profile dialog box to assign a user profile, logon script, or home directory to user accounts. These assignments are optional.

### To configure the user environment profile

1. Choose the Profile button from the New User, Copy Of, or User Properties dialog box.
2. Optionally, to assign a user profile, in the User Profile Path box type its full pathname.

The path should be a network path. The filename can be that of a personal user profile (.USR filename extension) or a mandatory user profile (.MAN filename extension). You might type, for example, **\\puma\profiles\clerks.man**.

When administering multiple user accounts, do not assign one personal profile to all the accounts. Either assign a mandatory profile, or substitute **%USERNAME%.USR** for the filename. You might type, for example, **\\hound\accounts\%username%.usr**.

3. Optionally, to assign a logon script, type the filename in the Logon Script Name box. If the logon script is stored in a subdirectory of the logon script path, precede the filename with that relative path.

For example, you might type **clerks.bat**. Or, you might type **admins\ernesta.cmd**.

4. Optionally, to specify a home directory, select the Connect box and specify a drive letter, and then select the To box and type a network path. Or, select the Local Path box and type a local path (including the drive letter).

For example, you might specify drive H and type a network path of **\\airedale\users\crystalw**. Or, you might type a local path of **c:\users\jeffho**. When administering domain user accounts, specify a network path.

Optionally, substitute **%USERNAME%** for the last subdirectory in the path. For example, you might specify drive Q and then type a network path of **\\airedale\accounts\%username%**.

Note: If no home directory is assigned here, the system assigns the user account the default local home directory (\USERS\DEFAULT on the user's local drive where Windows NT is installed).

5. Choose the OK button.

## **User Profile**

A user profile is a special file that is loaded by the system during a user's logon and defines the Windows NT environment that is created for that user. This definition includes all the user-specific settings of a user's Windows NT environment, such as Program Manager groups and the program items in those groups, screen colors, network connections, printer connections, mouse settings, window size and position, and more.

Note: User profiles cannot be assigned to the user accounts of a Windows NT workstation. When administering a Windows NT workstation, the User Profile Path box is unavailable.

## **Logon Script**

When a logon script is assigned to a user account, it runs each time the user logs on. It allows an administrator to affect a user's environment without managing all aspects of it. One logon script can be assigned to one or more user accounts.

A logon script can be a batch file (.BAT or .CMD filename extension) or an executable program (.EXE filename extension). When a user logs on, the computer authenticating the logon locates the logon script by following the computer's logon script path, which is usually C:\WINNT\SYSTEM32\REPL\IMPORT\SCRIPTS. (If Windows NT is installed in a location other than C:\WINNT, this logon script path is adjusted accordingly.)

## **Home Directory**

A home directory is a directory that is accessible to a user and contains files and programs for that user. It becomes that user's default directory for the File Open and Save As dialog boxes, for the command prompt, and for all applications that do not have a working directory defined. A home directory can be assigned to a single user or it can be shared by many users. A home directory can be a shared network directory, or a local directory on a user's workstation.

If you specify a network path for the home directory, in most cases User Manager for Domains automatically creates that home directory. If it can't, a message is displayed instructing you to manually create the directory. If you do not assign a home directory to a user account, the system uses the default local home directory (\USERS\DEFAULT on the user's local drive where Windows NT is installed).

Home directories make it easier for an administrator to back up user files and delete user accounts, because they collect many or all of a user's files in one location.

## Using %USERNAME% in the User Profile Path

When entering a user profile path, %USERNAME%.USR can be entered as the filename of a personal profile, and the system later substitutes the user name of each user account for %USERNAME%. This is useful when multiple user accounts are selected.

For example, say you are administering eight user accounts. In the User Profile Path box you might type `\\cat\profiles\%username%.usr`, and then choose the OK button. As the User Environment Profile is saved, for each user account the system substitutes the actual user name for the %USERNAME% entry.

%USERNAME% cannot be used in mandatory user profiles.

Note: When assigning user profile paths that are stored on a FAT volume, if the user name of at least one of the selected user accounts is longer than 8 characters (or longer than 8.3 characters), do not use the %USERNAME% wild card. However, for NTFS volumes this limit does not apply, and you can use %USERNAME% regardless of the user name length.

## Using %USERNAME% in the Home Directory Path

When typing the path for a home directory, %USERNAME% can be entered as the last subdirectory in the path, and the system later substitutes the user name of each user account for %USERNAME%. This is useful when multiple user accounts are selected.

For example, say you are administering six user accounts. You might select the Connect option, select a drive letter of H, type a path of \\airedale\users\%username%, and then choose the OK button. As the User Environment Profile is saved, for each user account the system substitutes the actual user name for the %USERNAME% entry.

Note: When assigning home directories that are on a FAT volume, if the user name of at least one of the selected user accounts is longer than 8 characters (or longer than 8.3 characters), do not use the %USERNAME% wild card. However, for NTFS volumes this limit does not apply, and you can use %USERNAME% regardless of user name length.

## Managing Logon Hours

Use the Logon Hours dialog box to restrict the days and hours during which a user can connect to a server. The default is to allow a user to connect during all hours of all days of the week, but you can optionally restrict a user to certain days and hours. This does not affect a user's ability to use a workstation.

### To manage logon hours

1. Choose the Hours button from the New User, Copy Of, or User Properties dialog box.
2. In the Logon Hours dialog box, select the hours to be administered.

To select one hour, click the box for that hour. To select a block of hours, click the beginning of the block and drag through the rows and columns to the end of the block. To select one entire day, click that day in the left column. To select one hour for all seven days, click the top box of that column. To select the entire week, click the top left box (above Sunday).

3. To allow connections during the selected hours, choose the Allow button. Or, to deny connections during the selected hours, choose the Disallow button.
4. Repeat steps 2 and 3 as necessary.
5. Choose the OK button.



## **Managing Logon Workstations**

Use the Logon Workstations dialog box to restrict the workstations from which users can log on to domain accounts. The default is to allow a user to log on from any workstation, but you can optionally allow a user to log on only from specified workstations.

### **To manage logon workstations**

1. Choose the Logon From button from the New User, Copy Of, or User Properties dialog box.
2. Select either User May Log On To All Workstations or User May Log On To These Workstations.
3. If you select User May Log On To These Workstations, type a computer name in at least one and up to eight of the numbered boxes.
4. Choose the OK button.

## **Managing Account Information**

Use the Account Information dialog box to define an account expiration date (if any) and the account type for the selected user accounts.

### **To manage user account information**

1. Choose the Account button from the New User, Copy Of, or User Properties dialog box.
2. Under Account Expires, select either Never or End Of.
3. If you select End Of, specify an expiration date in the End Of box.
4. Under Account Type, select either Global Account or Local Account.

Most accounts are global accounts. Assign local accounts only when a trust relationship does not exist with the user's home domain.

5. Choose the OK button.

## **Disabling User Accounts**

A disabled user account still exists and is listed in the User Manager for Domains window, but logons to that account are not permitted. Disabled accounts can be restored to enabled status at any time.

### **To disable or enable a user account**

1. In the User Manager window, select one or more user accounts.

The built-in Administrator account cannot be disabled.

2. From the User menu, choose Properties.
3. To prevent logons to the selected user accounts, select the Accounts Disabled check box. Or, to permit logons to the selected user accounts, clear the Accounts Disabled check box.
4. Choose the OK button.

## Deleting User Accounts

Be certain you want to delete a user account before you do so, because a deleted user account cannot be recovered. Internally, Windows NT knows every user account by its security identifier (SID), a unique number that identifies it. If you delete a user account and then create another user account with the same user name, the new user account will not have any of the rights or permissions that were previously granted to the old user account, because the user accounts have different SID numbers.

Because of this, it is a good idea to first disable a user account, and then periodically delete the workstation's disabled accounts. This is a low-risk way to remove users from the workstation.

### To delete one or more user accounts

1. In the User Manager window, select one or more user accounts.

The built-in Administrator and Guest accounts cannot be deleted.

2. From the User menu, choose Delete.
3. If a confirmation message is displayed, choose the OK button.
4. When the delete message is displayed, choose the Yes button. If multiple user accounts are selected, choose the Yes To All button.

## Selecting User Accounts

The Select Users command allows you to quickly and easily select or deselect all the user accounts that are members of selected groups. However, only the user accounts listed in the User Manager for Domains window are selected or deselected. Although local groups can contain user or group accounts not from the local domain, those accounts are not affected by choices made in the Select Users dialog box.

Note: When Low Speed Connection is selected, the Select Users command is unavailable.

### To select multiple user accounts

1. In the User Manager for Domains window, either select the user accounts you want to be initially selected, or select any group to make sure no user accounts are initially selected.
2. From the User menu, choose Select Users.
3. To select the member users of a group, select the group from the list and then choose the Select button.
4. To deselect the member users of a group, select the group from the list and then choose the Deselect button.
5. Repeat steps 3 and 4 as necessary.
6. Choose the Close button. The selected accounts are highlighted in the User Manager for Domains window.

Now that the desired accounts are selected, you can choose a command from the User menu. For example, you might choose Properties and simultaneously modify all the selected user accounts in the same way.

### To create a new global group

If you selected one or more user accounts in step 1, the selected users are the initial members of the new group.

" / \ [ ] : ; | = , + \* ? < >

4. In the Description box, type a description.
5. To add members to the global group, select one or more user accounts from the Not Members box, and then choose the Add button. Or, select one or more user accounts from the Not Members box, and then drag one of the selected icons to the Members box.
6. To remove members from the global group, select one or more user accounts from the Members box, and then choose the Remove button. Or, select one or more user accounts from the Members box, and then drag one of the selected icons to the Not Members box.
7. When the membership of the global group is defined, choose the OK button.

## **Managing the Account Policy**

The Account policy controls how passwords must be used by all user accounts.

### **To manage the Account policy**

1. From the Policies menu, choose Account.
2. Under Maximum Password Age, enter a value between 1 and 999 days, or select Password Never Expires.
3. Under Minimum Password Age, enter a value between 1 and 999 days, or select Allow Changes Immediately.

If here you select the Allow Changes Immediately option, then under Password Uniqueness you must select the Do Not Keep Password History option.

4. Under Minimum Password Length, enter a value between 1 and 14 characters, or select Permit Blank Password.
5. Under Password Uniqueness, enter a value between 1 and 8 passwords, or select Do Not Keep Password History.

If here you enter a uniqueness value (for example, Remember 4 Passwords), then under Minimum Password Age you must specify an age value (for example, Allow Changes in 7 Days).

6. Select or clear the Forcibly Disconnect Remote Users From Server When Logon Hours Expire check box.
7. Choose the OK button.

## **Managing the User Rights Policy**

A right authorizes a user to perform certain actions on the system. Use the User Rights policy to manage the rights granted to groups and user accounts.

Note: In most situations, the easiest way to provide rights to a user is to add that user's account to one of the built-in groups that already possesses the needed rights, rather than by managing the User Rights policy.

### **To manage the User Rights policy**

1. From the Policies menu, choose User Rights.
2. Select a user right from those listed in the Right box. When you select a right, the Grant To box lists the groups and user accounts that are granted that right.
3. To grant that right to additional groups or user accounts, choose the Add button and complete the Add Users And Groups dialog box that appears.
4. To remove a group or user account from the list of those granted this right, select a name in the Grant To box, and then choose the Remove button.
5. Repeat steps 2 through 4 as necessary.
6. To administer the advanced user rights, select the Show Advanced User Rights option, and then perform steps 2 through 4. Advanced rights are primarily used by programmers writing applications to run on Windows NT.
7. Choose the OK button.

## **Managing the Audit Policy**

Windows NT can track selected activities of users, by auditing security events and then placing entries in a computer's security log. Windows NT can record a range of security event types, from a system-wide event such as a user logging on, to an attempt by a user to read a specific file. Both successful and unsuccessful attempts to perform an action can be recorded.

Use the Audit policy to determine the types of security events Windows NT will log. When administering domains, the Audit policy affects the security logs of the domain controller and of all servers in the domain, because they share the same Audit policy. When administering a Windows NT workstation, this policy affects only the security log of that computer.

Because the security log is limited in size, carefully choose the events to be logged. The maximum size of each computer's security log is defined in Event Viewer. Entries in a security log can be reviewed using Event Viewer.

### **To manage the Audit Policy**

1. From the Policies menu, choose Audit.
2. To record events in the security log, select Audit These Events. Or, to not record any events in the security log, select Do Not Audit.
3. If you selected Audit These Events, specify the events to be audited by selecting or clearing the Success and Failure check box for each type of event.
4. Choose the OK button.

## Permitting Another Domain to Trust

Establishing a trust relationship requires two steps: first, one domain must permit a second domain to trust it, and then the second domain must be set to trust the first domain. Because the trust relationship is not yet established, it may often be necessary for these two steps to be performed by separate administrators.

### To permit another domain to trust this domain

1. If User Manager for Domains does not already display the appropriate domain, from the User menu choose Select Domain, and complete the Select Domain dialog box that appears, specifying the name of the domain that will be configured to permit another to trust it.

2. From the Policies menu, choose Trust Relationships.

The Trust Relationships dialog box lists the trust relationships for the domain.

3. Choose the Add button next to the Permitted To Trust This Domain box.

4. In the Domain To Permit box, type the name of the Windows NT Advanced Server domain that will be allowed to trust this domain.

You can type a name using both uppercase and lowercase characters, but the name will always be displayed uppercase.

5. Type a password in both the Password and Confirm Password boxes.

Passwords are case sensitive. (Windows NT distinguishes between uppercase and lowercase characters in passwords.)

6. In the Permit Domain To Trust dialog box, choose the OK button

In the Trust Relationships dialog box, the added name is displayed in the Permitted To Trust This Domain list.

7. In the Trust Relationships dialog box, choose the Close button.

8. Provide the password to the administrator of the domain that you have permitted to trust this domain. That administrator must complete the trust relationship by having that domain trust this one.

7. In the Add Trusted Domain dialog box, choose the OK button.

In the Trust Relationships dialog box, the added name is displayed in the Trusted Domains list.

8. In the Trust Relationships dialog box, choose the Close button.

Allows a user to shut down Windows NT at the computer.

Note: When administering a domain, this right applies to the domain controller and the other servers of the domain. When administering a workstation, this right applies only to that workstation.

## **Username**

The user name identifies the user account. A user name cannot be identical to any other user or group name of the domain or computer being administered. It can contain any uppercase or lowercase characters except for the following:

- ▶ In the Username box, enter a unique name of up to 20 characters.

## Logon Script Name

If a logon script is assigned to a user account, it runs each time the user logs on. It can be a batch file (.BAT or .CMD filename extension) or an executable program (.EXE filename extension). One logon script can be assigned to one or more user accounts. When a user logs on, the server authenticating the logon locates the logon script by following the server's logon script path (usually C:\WINNT\SYSTEM32\REPL\IMPORT\SCRIPTS).

■ To assign a logon script to the selected users, type a filename in the Logon Script Name box. If the logon script is located in a subdirectory of the logon script path, precede the filename with that relative path.

For example, you might type **clerks.bat**; or, you might type **admins\ernesta.cmd**.

## **Logon Script**

For Microsoft LAN Manager, a logon script is a batch program containing LAN Manager and operating system commands used to configure workstations. A logon script can be assigned to one or more users. When the user logs on, the logon script runs on the server.

- ▣ Optionally, to assign a logon script, type the filename in the Logon Script box.



## Logon Script Name

If a logon script is assigned to a user account, it runs each time the user logs on. It can be a batch file (.BAT or .CMD filename extension) or an executable program (.EXE filename extension). One logon script can be assigned to one or more user accounts. When a user logs on, the workstation locates the logon script by following the workstation's logon script path (usually C:\WINNT\SYSTEM32\REPL\IMPORT\SCRIPTS).

■ To assign a logon script to the selected users, type a filename in the Logon Script Name box. If the logon script is located in a subdirectory of the default logon script path, precede the filename with that relative path.

For example, you might type **clerks.bat**; or, you might type **admins\ernesta.cmd**.

## **Home Directory**

A home directory is a directory that is accessible to a user and contains files and programs for that user. It becomes that user's default directory for the File Open and Save As dialog boxes, for the command prompt, and for all applications that do not have a working directory defined. A home directory can be assigned to a single user or it can be shared by many users. A home directory can be a shared network directory or a local directory on a user's workstation.

If you specify a network path for the home directory, in most cases User Manager for Domains automatically creates that home directory. If it can't, a message is displayed instructing you to manually create the directory. If you do not assign a home directory to a user account, the system uses the default local home directory (\USERS\DEFAULT on the user's local drive where Windows NT is installed).

Home directories make it easier for an administrator to back up user files and delete user accounts, because they collect many or all of a user's files in one location.

## **Home Directory**

A home directory is a directory that is accessible to a user and contains files and programs for that user. For Microsoft LAN Manager, this can be a directory local to the user, or a directory on a server running user-level security.

■ To specify a home directory for a user, in the Home Directory box, type the path for that directory. This can be an absolute path or a network path. The suggested path follows the form `\\servername\USERS\username`.

### **Local Path**

☐ Optionally, to specify a home directory at the workstation where the user logs on, type a local path in the Local Path box.

For example, you might type **c:\users\johnbr**.

### **Connect To**

☐ Optionally, to specify a shared network directory as the home directory, specify a drive letter in the Connect box, and then type a network path in the To box.

For example, you might specify drive J, and then type `\\airedale\users\johnbr.`

## **About the Calendar**

The Logon Hours dialog box displays a one-week calendar, with logon hours indicated in one-hour increments across seven days. One box represents each hour. For example, the first box in each row represents the hour from midnight through 12:59 A.M.; the last box in each row represents the hour from 11:00 P.M. through 11:59 P.M.


When a box on the calendar is filled, the user is allowed to connect to servers during that hour. When a box is empty, the user cannot connect to servers during that hour.

### **Allow button**

☑ To allow connections during certain hours, select those hours and then choose the Allow button. The selected boxes are filled, indicating connections are allowed during those hours.

## **Disallow button**

When a user is connected to a server and logon hours are exceeded, the user is either disconnected from all server connections, or is allowed to remain connected but is denied any new connections. This behavior depends on an option (called Forcibly Disconnect Remote Users From Server When Logon Hours Expire) in the Account Policy dialog box.

**Account Expires**

When an account has an expiration date, the account is disabled at the end of that day. When an account expires, a user who is logged on remains logged on but can establish no new network connections, and after logging off cannot log back on.



**Never**

If you choose Never, the account will not expire.

**End Of**

If you choose End Of, you must specify an expiration date in the End Of box. The account becomes disabled at the end of the specified day.

## **Account Type**

User accounts are either global or local accounts. Most accounts are global accounts.

A global account is a normal user account in the user's home domain. A local account is an account provided in this domain for a user whose global account is not in a trusted domain.

## **Global Account**

A global account is a normal user account in the user's home domain. Most accounts are global accounts (and this is the default). If there are multiple domains available, it is best if each user in the network has only one global account in only one domain, so that there is only one password for the user.

In the User Manager window, global accounts are represented by the global account icon.

## **Local Account**

A local account is an account provided in this domain for a user whose regular account is not in a trusted domain. This might be a Windows NT Advanced Server domain that is not trusted by this domain; a LAN Manager domain; or another type of domain or network.

Local accounts can be used to access Windows NT and Windows NT Advanced Server computers over the network, and can be granted resource permissions and user rights. However, local accounts cannot be used to log on interactively at Windows NT and Windows NT Advanced Server computers. Local accounts created in one domain cannot be used in trusting domains, and do not appear in the Add Users And Groups dialog boxes of trusting domains.

It is best for local accounts to use the same password here as they do in their home domain.

**Administrator**

The user can perform all actions on the server.

Always assign a password to a user account that is granted the Administrator privilege level.

## **User**

The user can employ network resources (subject to the access permissions for the resources), view information about shared resources, view printer and communication-device queue status, and send and receive messages. The user account is a member of the special Users group, to which permissions can be assigned. This is the default privilege level and is granted to most network users.

An account granted the User privilege level can optionally be assigned one or more of the user operator privileges.

**Guest**

The user has the same abilities as a user granted User privilege, but is a member of the special Guest group instead of the Users group. To exclude temporary or occasional users from the Users group, give an account Guest privilege.



**Account Operator**

The user can create, remove, and modify user accounts that have User or Guest privilege; create, remove and modify groups; and modify logon restrictions.

The user cannot modify an account that has Administrator privilege, except to change group memberships. The user cannot change an account's privilege level to Administrator.

**Print Operator**

The user can share and stop sharing printer queues; create, remove, and modify printer queues; control print jobs; and view a list of all resources shared on the server, including resources available only to Administrators.

**Server Operator**

The user can start and stop services; share and stop sharing resources; read and clear the error log; close user sessions and the files users have opened; and view a list of all the resources shared on the server, including resources available only to Administrators.

**Comm Operator**

The user can share and stop sharing communication device queues; control communication device queue requests; and view a list of all resources shared on the server, including resources available only to Administrators.

## Trust Relationships

## **trust relationship**

A trust relationship is a link between two Windows NT Advanced Server domains, where one domain honors the users of another domain, trusting the logon authentications performed by that other domain for its own users. User accounts and global groups defined in a trusted domain can be granted rights, resource permissions, and local group memberships at a trusting domain and its member computers, even though those accounts don't exist in the trusting domain's security database.

When trust relationships are properly established between all the domains of a network, they allow a user to have only one user account and one password in one domain, yet to access the entire network.

## **Trusted Domains**

The Trusted Domains box lists the domains that this domain trusts.

Only Windows NT Advanced Server domains can be trusted.

## **Permitted to Trust this Domain**

The Permitted To Trust This Domain box lists the domains that are allowed to trust this domain.

Only Windows NT Advanced Server domains can be permitted to trust.



## **Add buttons**

Note that establishing a trust relationship requires two steps performed at two different domains: first one domain must permit a second domain to trust it, and then the second domain must be set to trust the first domain.

➤ To add a new trusted domain, choose the Add button adjacent to the Trusted Domains box, and then complete the Add Trusted Domain dialog box that appears.

## **Low Speed Connection**

When administering a domain or computer that communicates with your computer across a connection providing relatively low transmission rates, some User Manager for Domains functions may be performed slowly. This particularly affects the speed at which lists of user accounts, groups, or computers can be produced and displayed. In this situation, you can reduce delays by using the Low Speed Connection option.

For example, from a Windows NT Advanced Server you might administer a remote Windows NT workstation that is running the Microsoft Windows NT Remote Access Service and is connected to the network by a modem over telephone lines. When entering the computer name in User Manager for Domain's Select Domain dialog box, you should select the Low Speed Connection option.

The Low Speed Connection option can also be selected or cleared by choosing Low Speed Connection from the Options menu.

The list presents the matching users in the form *domainname\username (full name) description* or *computername\username (full name) description*.

The list presents the matching groups in the form *domainname\groupname description* or *computername\groupname description*.

**Add button**

Closes the Find Account dialog box, and adds the accounts selected in the Search Results list to the Add Names list of the Add Users And Groups dialog box.

## **Enter Server**

The domain could not be found. It may not exist, or you may have misspelled the domain name, or the domain may be located across a network bridge.

Note: Broadcast messages such as the one generated by Add Trusted Domain are not usually passed across wide area network (WAN) bridges.

### **If you misspelled the domain name**

☐ Choose the Cancel button, and then in the Add Trusted Domain dialog box type the correct domain name.

## About the User Profile Path

A user profile is a special file that is loaded by the system during a user's logon and defines the Windows NT environment that is created for that user. This definition includes all the user-specific settings of a user's Windows NT environment, such as Program Manager groups and the program items in those groups, screen colors, network connections, printer connections, mouse settings, window size and position, and more.

Each Windows NT computer maintains a default user profile. If a user account does not have a user profile assigned, at the first logon to that account from a Windows NT computer, that computer's default user profile is loaded. A copy of this profile is saved, along with any changes the user makes to the Windows NT environment. At all subsequent logons from that computer, the user's copy of the profile is loaded. In this way a user's Windows NT configuration is saved from one session to the next. However, a different user profile is saved at each Windows NT computer the user logs on from.

Optionally, you can create user profiles with User Profile Editor and save them in shared network directories. With User Manager for Domains, you can assign these user profiles to user accounts. Using user profiles you have created differs in several ways from using a computer's default user profile:

- ▣ A user can move between various Windows NT computers in the network, yet still receive a consistent Windows NT environment. Since the user profile is stored in a network directory, it can be loaded no matter which Windows NT computer the user logs on from.
- ▣ If appropriate, a single user profile can be assigned to a group of users who perform similar tasks. In this way a common configuration can be shared by multiple users.
- ▣ If appropriate, an administrator can use the user profile to restrict a user's access and capabilities, by using options provided by User Profile Editor.

There are two types of user profiles that can be assigned to user accounts:

- ▣ Personal user profiles. Each must be assigned to only one user. A personal user profile retains any changes the user makes to the Windows NT environment. At every logon, the user receives the newest version of his or her environment. Filenames of personal user profiles end in the .USR filename extension.
- ▣ Mandatory user profiles. These can be assigned to any number of users. A mandatory user profile permanently defines the user's Windows NT environment, so that the original, unmodified settings are always loaded at every logon. Filenames of mandatory user profiles end in the .MAN filename extension.

You assign user profiles to user accounts by specifying a full pathname in User Manager for Domains. Here are some examples:

- ▣ You might assign one mandatory profile to one or more user accounts by specifying, for example, a user profile path of \\AIREDALE\CLERKS\CLERKS.MAN.
- ▣ You might assign a personal profile to one user account by specifying, for example, a user profile path of \\WOLFHOUND\ACCOUNTS\JEFFHO.USR.
- ▣ You might assign separate personal profiles to multiple user accounts by specifying, for example, a user profile path of \\CAT\PROFILES\%USERNAME%.USR.

After a user profile path is assigned to a user account, it may or may not be necessary to create the specified user profile and place it in the specified network directory.

- ▣ If you assign a mandatory user profile to a user account, you must create a profile of that name and place it in the specified network directory. At logon, if the assigned mandatory user profile is not found, the logon attempt is denied.
- ▣ If you assign a personal user profile to a user account, you can optionally create a profile of that name and place it in the specified network directory. It is loaded every time the user logs on.

However, if a personal user profile of that name is not created, then at the user's first

logon to that account, the system copies the default user profile from the user's logon computer and saves it under the specified filename in the specified network directory. This allows you to assign personal user profiles to many user accounts with User Manager for Domains, without the need to individually create each personal user profile with User Profile Editor.
