### **Message Spy VBX Custom Control for Microsoft Visual Basic version 2 and above**

#### **Licence Agreement**

The Message Spy Custom Control ("the Software") is a Visual Basic custom control (VBX) licensed by Anton Software Limited ("ASL") as part of the Anton Software Library/VBX.

Your use of the Message Spy Custom Control indicates your acceptance of the following terms and conditions:

#### **Shareware Licence**

You are free to distribute the entire unmodified contents of the distribution package (msgspy.zip - "the Package") to anyone you wish. For a period of no more than 28 days, you may use, test and duplicate the enclosed version of the Software. Thereafter, if you wish to continue using the Software you must register it with ASL, or else you must cease all use of the Software. You must pay the registration fee if you continue to use this version of the Software for more than 28 days.

#### **Registered User Licence**

If you pay the registration fee for the Software to ASL, ASL will grant you a non-exclusive licence for one person to use one copy of the software regardless of whether the owner of the licence ("the Licensee") is a person or a business. In addition, the Licensee may distribute the Message Spy Visual Basic Custom Control ("the VBX") with any or all products that use the VBX with the exceptions that (1) the recipients of any such program ("the Recipients") may not further redistribute the VBX, and (2) the product using the VBX cannot enable the Recipient to produce other programs using the VBX or other parts of the Package, and (3) the product using the VBX must contain a notice stating ASL's copyright of the VBX. No purported transfer of the licence shall be effective until the licensee notifies ASL of the name and address of the person receiving the licence ("the Transferee"), and transfers all copies of the Software to the Transferee, and removes or destroys any other copies of the Software in the possession of, or under the control of, the Licensee.

#### **Limited Warranty**

The Software is distributed and licensed under an "as is" basis. Registration of the Software implies acceptance of it and of this licence agreement. Nevertheless, ASL warrants that the Software will perform substantially as specified for 90 days from the date of receipt. Upon registering, ASL will provide support as indicated under Limitation of Remedies below.

#### **Disclaimer of Warranties**

ASL makes no claims as to the suitability of the software for any specific purpose. ASL disclaims any and all other warranties express or implied, written or oral. You may have other rights which may vary from country to country and state to state.

#### **Limitation of Liability and Remedies**

ASL's entire liability and your exclusive remedy shall be, at ASL's discretion, either (1) return of the registration fee paid less \$5 processing fee or (2) repair or replacement of the Software that does not meet ASL's Limited Warranty. In no event shall ASL be liable for any damages whatsoever arising out of the use of the Software, including without limitation any direct, indirect or consequential damages or any damages for business interruption, loss of profits, loss of information, or any pecuniary loss even if ASL has been notified of the possibility of such damages. The limitation or exclusion of liability for incidental or consequential damages may not be allowed in some countries and states, and in these countries and states those particular

limitations do not apply.
