PART EXECUTION

EXAMINATION

Examine substrate conditions before beginning
installation of vinyl products; verify dimensions and
acceptability of substrate.

Do not proceed with installation of vinyl products until
unacceptable conditions have been corrected.

INSTALLATION

Installation of vapor retarder is specified in Section
07260.

Install vinyl products in accordance with manufacturer's
printed installation instructions.

Attach vinyl products to substrate for weathertight installation; ensure that horizontal components are installed true to level, that vertical components are installed true to plumb.

Installation of joint sealers is specified in Section 07900.

ADJUSTING AND CLEANING

Clean dirt from surface of installed products, using mild soap and water.

After completing installation of vinyl products, remove from project site excess materials and debris resulting from installation of vinyl products.
