Maintenance for 8900 Series

Install 3M Nomad or Carpet Mats at all room entry ways to prevent debris from entering the room. Dust mop the 8900 ESD floor daily with a clean, dry dust mop. If needed, damp mop with clean mop heads and clean, warm water 3M Spangle Neutral Floor Cleaner diluted in accordance with the directions on the label. An automatic scrubber or floor buffer may be used with 3M Spangle Neutral Floor Cleaner diluted in accordance with the directions on the label. Use only 3M White, Red or Tan Line Buffer Pads.
