Design Flo-Crete to be applied directly to concrete after all sediments, oils or foreign matter have been removed by either etching and degreasing with Seamco's Degreaser and Etch cleaner or surface layer of concrete has been removed. Cracks and deviations in concrete to be removed with Seamco Patching compound. Design Flo-Crete systems to be applied according to factory specification by qualified applicator. Two coats of Seamco sealer to be applied as part of final application. Sealer used depends on Flo-Crete system, surrounding environment, residential, commercial, and industrial. This applies to all application methods, vertical or horizontal.
