GUIDELINE SPECIFICATIONS

PART I - GENERAL

1.01 DESCRIPTION

A. SCOPE OF WORK

1. The furnishing of interlocking suspended synthetic (Polyolefin Polypropylene copolymer proprietary formulation) modular system as manufactured by Sport Court Inc., Salt Lake City, Utah.
2. Acoustical underlayment and game lining is manufactured by others and installed by owner with installation instructions and supervision by Sport Court Inc. and/or its authorized representative.

B. RELATED WORK SPECIFIED ELSEWHERE

1. Installation of concrete, bituminous or wood substrate.
2. Preparation of substrate to provide a medium, dense finish with level tolerances of (+) or (-) 1/8th inch in any 10-foot radius.
3. Membrane waterproofing. It is the responsibility of the engineer to determine the extent of this need.
4. Gymnasium floor inserts.
5. Cove base molding and thresholds.

1.02 QUALITY ASSURANCE

A. ACCEPTABLE INSTALLER

1. Sport Court® flooring shall be installed and/or supervised by an authorized factory-trained dealer or representative.
2. Successful bidder must submit a list of completed projects of similar magnitude and complexity over a two year period.

1.03 STORAGE

A. STORAGE OF MATERIAL

1. The general contractor shall provide a secure, clean and dry location for storage material.

1.04 JOB CONDITIONS

A. SCHEDULE OF INSTALLATION

1. Sport Court® flooring must not be applied until all other trades except bleachers, basketball goals and side moldings are completely finished in the area and surrounding rooms.
2. Substrate shall be level to specified tolerances free of debris and materials and broom clean.

1.05 WARRANTY

A. MANUFACTURER'S LIMITED WARRANTY

1. Sport Court® flooring shall be warranted by the manufacturer for any defects in materials and workmanship for a period of ten years from date of purchase as set forth in the warranty attached.

PART 2 - EXECUTION

2.01 Inspection

A. SUBSTRATE

1. Substrate shall be checked by the dealer for contamination, dryness and level. Any deviation from specification should be reported in writing to the general contractor for correction.
2. General contractor shall correct deficiencies in substrate and advise dealer in writing of conformity to specifications.
