1. Presentation

ICCD is a CD Audio player program. It has been specially designed for Windows 95 and Windows NT 4.0. It is beautiful and efficient. It offers all the common features of your HI-FI CD Player. The only difference is that ICCD is simpler: just insert your CD-Audio in your computer and ICCD will run (you must run once ICCD to get this capability).

2. Registration

If you read this file, you have already installed ICCD. If you want to use the autorun feature that allows you to run automatically a CD when inserting it in your CD player, you must run ICCD once before.

4. Uninstallation

If you want to uninstall ICCD:

- Delete ICCD directory
- Delete the \Windows\ICCD Directory
- Reinstall the Microsoft CD Player (go in the control panel, choose Add program/software, then Windows Installation, Multimedia, click on Details... then check CD Player).

No help will be provided for uninstalling ICCD!
