INSTALLATION:

NOTE: This program requires the VB 5 runtime files to work. These files can be found on most bulletin boards and online services such as CompuServe and America OnLine. If you are unable to locate this file please contact the author at the internet address below and you will be provided a copy <u>at your expense</u>. This program must be installed on Microsoft Windows 95, it will not work on any previous versions. This program *may* work on Windows NT 4.0, but has not been tested.

If you have a previous version of Theme Weaver, uninstall the old version by following the procedures outlined below in the 'Uninstall Application' section. If you do not uninstall the old version, you will have two copies of the program on your computer.

To install Theme Weaver, unzip weaver.zip to a floppy diskette. From Windows' Start Button, choose RUN and type in the path.

Example: A:\SETUP.EXE

Theme Weaver will ask you if you want the default installation directory. If so, continue with the installation. If you wish to put Theme Weaver in another location, enter the desired path. Once the installation is complete, you can click on the Theme Weaver icon in the Start menu under McNair Software and begin using the application. If you have any comments or questions about Theme Weaver, please feel free to contact me by e-mail at the address below.

REGISTRATION:

Theme Weaver is being distributed as shareware, it is not free software. This means you are allowed to legally use the program for no more than 30 consecutive days after installation. Reinstallation of the program to circumvent the 30 day evaluation period is illegal and prohibited. After 30 days you must determine if you like Theme Weaver. If so, you are required to register. It is a copyright violation to continue using Theme Weaver after the 30 day trial period. It is also a copyright violation to distribute themes that have been created with an unregistered copy of Theme Weaver.

Since there are no disabled portions in the shareware version of Theme Weaver, it is up to you to be honest and register. Registration allows me to continue application development. To register, simply print and completely fill out 'Register.doc' that was included with the install files of this program. Then send it along with remittance to the address listed.

Company policy dictates that absolutely no support will be given to unregistered copies of Theme Weaver.
