App Director Registration Information

All versions of App Director are not public domain software, nor are they free software. They are being distributed under the shareware concept.

What is Shareware?

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details -- some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. (In both cases, there are good programs and bad ones!) The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all and sundry or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocketbook, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee -- if you don't use the product, you don't pay for it.

Paying the small shareware fee for something you find useful encourages the free exchange of information currently enjoyed by the software community. It also encourages the author to support and upgrade the program.

App Director is a "shareware program" and is provided at no charge to the user for evaluation. Feel free to share it with your friends, but please do not give it away altered or as part of another system. The essence of "user-supported" software is to provide personal computer users with quality software without high prices, and yet to provide incentive for programmers to continue to develop new products. If you find this program useful and continue to use App Director after the trial period, you must make the requested registration payment to QPC Solutions, Inc.

The registration fee will license one copy for use on any one computer at any one time. You must treat use of this software just like use of a book. This software, like a book, may be used by one person at a time and it may only be installed on one computer at a time. Just as a book

cannot be read by two different persons at the same time.

Commercial users of App Director must register and pay for their copies of App Director within 30 days of first use or their license is withdrawn. Site-License arrangements may be made by contacting QPC Solutions.

Anyone distributing App Director for any kind of remuneration must first contact QPC Solutions at the address below for authorization. This authorization will be automatically granted to distributors recognized by the (ASP) as adhering to its guidelines for shareware distributors, and such distributors may begin offering App Director immediately (However QPC Solutions must still be advised so that the distributor can be kept up-to-date with the latest version of App Director.).

You are encouraged to pass a copy of App Director along to your friends for evaluation, as long as the entire package is distributed to them. Please encourage them to register their copy if they find that they can use it. All registered users will receive the benefits explained below.

The Shareware Fee

To register as an authorized user of App Director, send QPC Solutions, Inc. the modest shareware fee. If you send us \$30 US:

- 1. You will be registered.
- 2. We will notify you of all major upgrades (in advance of their release).
- 3. We will mail you a license number and instructions for disabling the registration screen.

If you send us \$35 US (the additional \$5 to cover the cost of the disk and shipping), you will receive all the benefits listed above and will be mailed a diskette containing the most recent version of App Director and a bonus Windows alarm clock application.

Please print and use the order form included with the App Director package to order your choice of registration options.

Disclaimer Agreement

Users of App Director must accept this disclaimer of warranty:

"App Director is supplied as is. QPC Solutions, Inc. makes no warranty of any kind, express or implied, including without limitation, any warranties of merchantability and/or fitness for a particular purpose. QPC Solutions shall not be liable for any damages, whether direct, indirect, special or consequential arising from a failure of this program to operate in the manner desired by the user. The author shall not be liable for any damage to data or property which may be caused directly or indirectly by use of the program."

License Agreement

By installing a copy of App Director for evaluation, you are agreeing to be bound by the terms of this agreement.

Non-registered users are granted a limited license to use App Director for 30 days on a trial basis for the purpose of determining whether App Director is suitable for their needs. Use of App Director except for this limited purpose, requires registration. Use of non-registered copies of App Director by any person, business, corporation, governmental agency or other entity institution is strictly forbidden.

Registration permits a user the license to use App Director only on a single computer; a registered user may use the program on a different computer, but may not use the program on more than one computer at the same time.

No user may modify App Director in any way, including but not limited to decompiling, disassembling or otherwise reverse engineering the program.

All users are granted a limited license to copy App Director only for the trial use of others subject to the above limitations, and also the following:

App Director must be copied in unmodified form, complete with the file containing this license information and all other files that are a part of the package. These files are listed in the file README.APD.

The provided App Director documentation must be included with the copy. No fee, charge or other compensation may be accepted or requested by any licensee.

Operators of electronic bulletin board systems may post App Director for downloading by their users only as long as the above conditions are met. Shareware catalog businesses are welcome to post App Director in their catalog listings, but they may not charge more than a \$10 distribution fee for the application package.
