

This is my first attempt at creating a postscript typeface. Nicole Display is named after my wife Nicole. It is a derivative of Helvetica Medium.

#### INSTALLING NICOLE DISPLAY

#### PostScript version

If you are using system 6 or earlier: use Font/DA Mover to install the bitmap in the system file and copy the PostScript file into the system folder.

If you are using are using system 7: drag the icons of both the bitmap and PostScript file over the system folder. The system will place both files in their appropriate places.

Alternatively you can use a font handling utility like MasterJuggler or Suitcase to temporarily install the font.

# TrueType version

If you are using system 6: be sure you use the TrueType Init and the correct version of system 6. Then use Font/DA Mover to install the TrueType font in the system file.

If you are using system 7: drag the icon of the TrueType file over the system folder. The system will place it in its appropriate place.

Alternatively you can use a font handling utility like MasterJuggler or Suitcase to temporarily install the font.

#### **SHAREWARE**

Nicole Display is a shareware typeface. It may be freely distributed, and this is suggested, provided that it is not modified and that it is distributed together with this "Read me" file, and no fees are paid other than the ones that can come due to delivery, the medium or the transmission.

If, after a fifteen days trial period, you decide to keep Nicole Display, you are obliged to pay a licence fee for a right of use for on one entity, either legal or individual, and this for one computer. The licence fee is \$25 US or the equivalent in your own currency.
