JPT Big Cat Examples

Introduction

The JPT CM allows you to dial a selected number via JPT but it only allows you to dial that number using the dialing rules as defined in JPT and does not allow you to access the robust scripting capabilities that JPT offers. As a work around, you can use the terrific freeware CM "Big Cat Scripts Plugin" from Ranchero Software:

http://www.ranchero.com/bigcat/>

This plugin allows you to run any script on a selected file or text selection and, as such, can be used to highlight a number in an application and use a script to either customize the dialing rules in JPT or modify the number itself and then pass the number to JPT for dialing. To use the JPT Big Cat example AppleScripts, you must first install the Big Cat plugin and then, copy the JPT Big Cat AppleScripts to your Big Cat text scripts folder:

/Users/<your user name>/Library/Application Support/Big Cat Scripts/Text/
