## About DateDesist™

### **Quick Legal Info**

### DateDesist™

DateDesist will temporarily change the date on your PC, launch a program, then return back to the correct date. DateDesist will defeat most expiring programs. It is usually illegal to use DateDesist to defeat shareware, and that is not its intended purpose.

### **Main Window**

The main window in DateDesist has two selectable fields, *Keyword* and *Description*. To run a program, select one of these fields and click the *Start* button. To delete the currently selected program from DateDesist, click the *Delete* button. To add a new program to DateDesist, click *New*.

## **Command Line Arguments**

DateDesist supports keywords as command line arguments. Each program that you configure in DateDesist is assigned a unique keyword. To launch a program without user intervention, use the following syntax.

DateDesist.exe Keyword

# **Current Updates**

### Version 1.0

DateDesist was designed and developed.

### Version 2.0

The code was compiled to 32 bit, the background color was changed from florescent green to the standard gray, and the name was changed to DateDesist.

### Version 3.0 – May 1<sup>st</sup>, 1997

DateDesist was completely rewritten. I have redesigned the interface, and made it much easier to use. There is no longer a need to modify text files, or use strange command line arguments. Command line arguments are still available.

# Version 4.0.0 - May 17th, 1997

DateDesist was compiled in VB 5.0, and now requires the 5.0 runtimes. The size of the archived file should be reduced by over 1MB. The Edit button was added. I squished a bug that caused DateDesist to stop working if a filename with a comma "," was used.
