ACTIVISION DEBUTS DYNAMIC LINEUP OF GAMES FOR PLAYSTATION®2 COMPUTER ENTERTAINMENT SYSTEM AT 2003 ELECTRONIC ENTERTAINMENT EXPO

Santa Monica, CA – May 14, 2003 – Activision, Inc. (Nasdaq: ATVI) will debut a show-stopping slate of games for the PlayStation®2 computer entertainment system at the 2003 Electronic Entertainment Expo, which takes place at the Los Angeles Convention Center from May 14 - 16. The company's blockbuster lineup includes high-profile Hollywood licenses such as *Shrek*, *Disney's Extreme Skate Adventure*TM and the *X-Men*TM, as well as games based on original properties including *Pitfall*® *Harry*, *True Crime*TM: *Streets of L.A*TM and *Wakeboarding Unleashed*TM *featuring Shaun Murray*.

*Shrek 2*TM: *The Game* (working title) - Embark upon an adventure that goes beyond the movie with *Shrek 2: The Game*. Inspired by the upcoming film and expanding its storyline, the game features Shrek®'s signature humor and comedic interactions. Players experience key moments from the film and encounter a variety of new personalities, environments and sub-plots as they switch between Shrek®, Donkey or one of their many fairy tale friends. The game is being co-developed and co-published worldwide by TDK Mediactive and Activision, and is currently in development by Luxoflux. *Shrek 2: The Game* has not yet been rated by the ESRB.

Disney's Extreme Skate AdventureTM - Skate through the large and imaginative worlds of Walt Disney Pictures' presentation of Pixar Animation Studios' "Toy Story 2," "Disney's Tarzan®" and "Disney's The Lion King" along with the most memorable characters from each film. Using cutting-edge technology from Activision's *Tony Hawk's Pro Skater &* 4 game engine, *Disney's Extreme Skate Adventure* lets players perform fun and unique skating tricks as their favorite characters, "Extreme Skate Crew" member or unique Create-A-Skater creation. Both "Extreme Skate Crew" members and Create-A-Skater characters can skate through real world locales as well as be magically transported to environments from the films where they can use bamboo rafts, frying pans and hover-boards, solving puzzles as they go. *Disney's Extreme Skate Adventure* is being developed by Toys for Bob and has not yet been rated by the ESRB.

Pitfall® *Harry* - The daring, risk-taking explorer who laughs in the face of danger is back! Featuring over 50 levels of fast-paced action and puzzle solving adventures, the game challenges players to swing, fight, climb and crawl through eight types of treacherous South American environments including lush jungles, dark tombs, ancient Aztec ruins and glacial mountains. *Pitfall Harry* also includes favorite features from the earlier *Pitfall*® games such as vine swinging, gaping chasms, crocodiles and scorpions. Gamers can overcome the obstacles using all of the tools in Harry's arsenal including a sling, dynamite and ice axes, and rescue those in distress from deadly foes like snakes, scorpions and spiders. The game is being developed by Edge of Reality and has not yet been rated by the ESRB.

X-Men®: *Legends*TM - The first-ever X-Men real-time RPG allows gamers to assemble, train and lead their own X-Men fighting force in a battle against some of the deadliest foes in the Marvel Universe including the MorlocksTM, the Brotherhood of MutantsTM and robotic SentinelsTM. Players must draw on the powers of a diverse pool of X-Men and use teamwork to unleash the full power of their squad. *X-Men: Legends* is being developed by Raven Software and has not yet been rated by the ESRB.

*True Crime*TM: *Streets of L.A.*TM - Assume the role of Elite Operations Division (E.O.D.) Detective Nick Kang, a misunderstood, no-holds-barred badass cop tasked with taking down the Chinese Triad and Russian Mafia cartel that has turned the City of Angels into a war zone. With twin 45's and devastating martial arts skill, players prowl the streets of L.A. in a custom made police vehicle, while heading a top-secret task force out to restore law and order. In car or on-foot, the unique branching missions include locating hostile witnesses, searching for case-cracking clues, tracking down evasive informants and busting the heavily armed and deadly bad guys. *True Crime: Streets of L.A.* is being developed by Luxoflux and has not yet been rated by the ESRB.

*Wakeboarding Unleashed*TM *featuring Shaun Murray* - Hang on for your life and get ready to rip behind a high-powered speedboat as you trick through dangerous terrain. Feel the rush as you crash into houseboats and catch huge air in nine exotic levels with seven world-class wakeboarders. Tired already? Then drive the boat and help fellow riders pull off challenging technical tricks on the most realistic looking water ever. Wakeboarding Unleashed featuring Shaun Murray is being developed by Shaba Games, LLC and has not yet been rated by the ESRB.
