

## Hints on registering

### **Why register?**

Registering New Menus for Windows will disable the "Hello I'm Shareware" screen upon startup. As a registered user you will also be entitled to free support by the author via postal mail or electronic mail.

### **REGISTER VIA BMT MICRO**

If you are living in the USA or in Canada, you may register New Menus for Windows several ways with BMT Micro.

BMT Micro accepts Visa, MasterCard, and Discover as well as personal checks, money orders and cashier's checks. Please allow 10 days for personal checks to clear.

Voice Orders are accepted 7 days per week from 9:00 am until 8:00 pm EST. Fax orders are accepted 24 hours per day. Online registrations via our BBS are also available 24 hours per day.

### **Registration via CompuServe**

CompuServe members may register directly through the CompuServe Registration Service. To use this service enter GO SWREG at your CIS prompt. The \$20.00 registration fee will automatically be added to your CompuServe statement.

### **Register via EMail and bank transfer**

To register via E-Mail you have to instruct your bank to perform a wire transfer to my bank account. After wiring the funds, E-mail the registration form to: roger@architektur.uni-kassel.de or directly to me on CompuServe at 100412,3624. ### **Register via postal service directly with author**

To avoid the service charge for overseas bank transfers, the best way to

register is to send a letter with the printed registration form and payment (cash or Eurocheck). Please use a Eurocheck when possible.

Then, in a few days you will receive a letter via Mail or EMail with the registration code. Please note that I do not accept credit cards using this method of registration. Only send bank notes or Eurochecks by the postal service when registering with me directly.
