Definitions

The following definitions apply to the terms as they appear in this agreement:

The company means "CPTech (Southern) Ltd".

The user means you, the person with the software on his computer.

The software means the SysErrors program, and all accompanying files.

Trial period means the 30 days immediately following the first use of this software.

Trial Period

The company grants a 30 days licence for the use of the software, starting from the date of receipt, after which time it must either be registered with the company, with payment of the appropriate fee, or destroyed.

This licence terminated, and under no circumstances may the software be used, beyond the free 30 days trial period, unless the aforementioned registration has taken place.

This licence covers use of the software both before and after the 30 days trial period.

Distribution

Unless explicitly stated in writing, the company does not grant permission to distribute the software for profit in any form, including but not limited to distribution via bulletin boards, electronic services, disk, magnetic or optical media. However, the company does hereby grant permission for the non-profit distribution of the unregistered version of the software, providing that the software is provided in its complete and unmodified form with all accompanying documentation. For the purposes of this licence, non-profit includes on-line services which charge a reasonable fee for access, and commercial shareware or freeware collections on disk or CD-ROM which charge for the disk or CD, not the software on it. The registered version of this software must not be distributed in any form.

Copyright

This software is owned by the company and is protected by United Kingdom copyright laws and international treaties. Accepted uses

During the trial period, and upon registration the user is granted a non-exclusive licence to:

Reverse-engineer, disassemble, decompile, or make any attempt to discover the source code or scripting of the software.

Sub licence, rent, lease or loan the software or any portion of the software.
