#### **REGISTRATION:**

### To REGISTER:

# (Using Trakker)

- 1. Start Trakker.

### **OPERATION:**

If you installed Trakker on a drive other that "C:", please change the TRAKKER.INI defaults to reflect this. (If you installed in "D:\TRAKKER2" for example, simply change all

# references to "C:" in the TRAKKER.INI to "D:".) You can find the TRAKKER.INI in your \ WINDOWS directory. This is the ONLY place you will need it.

The Trakker .INI file should be kept in the Windows directory).

Trakker will only open and read files in it's native format, to do otherwise will result in an error.

To operate Trakker use the following as a guide:

After you have installed Trakker:

### To Receive Database Files:

- 1. Run Trakker.
- 2. Select "Database" from the File Menu.
- 3. Give it a unique name (in the pop-up box that follows), then select OK.
- 4. On the next dialog, select which forum to use from the dropdown list. Leaving "0" in the "Last Days" box will retrieve ALL file descriptions. So be prepared to be online atleast 10 minutes. Use "10" or "30" to retrieve the last 10 days or 30 days worth of uploads to a given forum.

### To Browse Database Files:

- 1. Run Trakker.
- 2. Select "Open" from the File Menu and select a Trakker file.
- 3. You may now search, export, print, download, etc.
