### New command (File menu)

Use this command to create a new document in DeskTools. Select the type of new file you want to create in the <u>File New dialog box</u>.

You can open an existing document with the <u>Open command</u>.

### Shortcuts

Toolbar: Keys: CTRL+N

# File New dialog box

Specify the type of document you wish to create:

Telephone List	list of phone numbers, addresses, and notes
Glossary List	list of chunk of information sorted by date
Reminder List	list of reminders, alarms, calendars and to-do lists
Text Document	small text processor

You can also open an existing document by pressing the **Open** button.

## **Open command (File menu)**

Use this command to open an existing document in a new window. You can open multiple documents at once. Use the Window menu to switch among the multiple open documents. See <u>Window 1, 2, ... command</u>.

You can create new documents with the <u>New command</u>.



## Select Document dialog box

You can create a new document by selecting the desired document type and pressing the button **Create New**. You can also open an existing DeskTools file by pressing the **Open** button. The open dialog box will open up so you can select a file to open.

### File Open dialog box

The following options allow you to specify which file to open:

### **File Name**

Type or select the filename you want to open. This box lists files with the extension you select in the List Files of Type box.

### List Files of Type

Select the type of file you want to open:

Telephone Lists Glossary Lists	.PHN .GLS	
Reminder Lists		.REM
Text Documents		.TXT

#### Drives

Select the drive in which DeskTools stores the file that you want to open.

### Directories

Select the directory in which DeskTools stores the file that you want to open.

### Network...

Choose this button to connect to a network location, assigning it a new drive letter.

### Close command (File menu)

Use this command to close all windows containing the active document. DeskTools suggests that you save changes to your document before you close it. If you close a document without saving, you lose all changes made since the last time you saved it. Before closing an untitled document, DeskTools displays the <u>Save As dialog box</u> and suggests that you name and save the document.

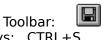
You can also close a document by using the Close icon on the document's window, as shown below:



### Save command (File menu)

Use this command to save the active document to its current name and directory. When you save a document for the first time, DeskTools displays the Save As dialog box so you can name your document. If you want to change the name and directory of an existing document before you save it, choose the Save As command.

#### Shortcuts



Keys: CTRL+S

### Save As command (File menu)

Use this command to save and name the active document. DeskTools displays the <u>Save As</u> <u>dialog box</u> so you can name your document.

To save a document with its existing name and directory, use the <u>Save command</u>.

### File Save As dialog box

The following options allow you to specify the name and location of the file you're about to save:

### File Name

Type a new filename to save a document with a different name. A filename can contain up to eight characters and an extension of up to three characters. DeskTools adds the extension you specify in the Save File As Type box.

### Drives

Select the drive in which you want to store the document.

### Directories

Select the directory in which you want to store the document.

#### Network...

Choose this button to connect to a network location, assigning it a new drive letter.

# 1, 2, 3, 4 command (File menu)

Use the numbers and filenames listed at the bottom of the File menu to open the last four documents you closed. Choose the number that corresponds with the document you want to open.

# Exit command (File menu)

Use this command to end your DeskTools session. You can also use the Close command on the application Control menu. DeskTools prompts you to save documents if there has been any changes.

### Shortcuts

Mouse: Double-click the application's Control menu button.

### Undo/Can't Undo command (Edit menu)

Use this command to reverse the last editing action, if possible. The name of the command changes, depending on what the last action was. The Undo command changes to Can't Undo on the menu if you cannot reverse your last action.

# Cut command (Edit menu)

Use this command to remove the currently selected data from the document and put it on the clipboard. This command is unavailable if there is no data currently selected.

Cutting data to the clipboard replaces the contents previously stored there.

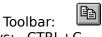

# Copy command (Edit menu)

Use this command to copy selected data onto the clipboard. This command is unavailable if there is no data currently selected.

Copying data to the clipboard replaces the contents previously stored there.

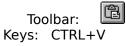

Use this command to clear the current selection in the document.

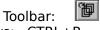

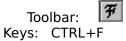
Use this command to select the font to be used by your printer. For diskette labels it is recommended to use a size no greater than 12. The title is automatically set to size 24.

### Set Printer Font command (Data menu: Reminder Lists)

Use this command to select the font to be used by your printer.

The title of the calendars is automatically set to size 5/4 the size you choose. This cannot be changed. The size of the small calendars at the bottom of the page is set to 3/4 the size you select. The font for the calendars is always *Courier New*. If you do not have this font then you may encounter problems printing small calendars. However, this is very unlikely to happen.



### Set Dial Settings command (Data menu: Telephone Lists)

Use this command to select your particular settings for dialing out. You can add a prefix to the number you wish to dial out. The most important setting is the port to be used. Other settings will be used in future versions.

## Telephone List (DeskTools Document)

A DeskTools document. You can maintain a list with phone numbers, business and home addresses, company name, and miscellaneous notes.

You can dial out by simply pressing a button. You can print your phone directory in two different formats. You can print any size labels, envelopes and rolodex cards. This works in matrix printers as well as laser printers.

The number of records is limited only by the size of your hard disk.

Any telephone list document **MUST** have extension **.PHN.** For each telephone file DeskTools generates two additional files with the same name and extensions **.DTP** (this one has the actual data) and another one with extension **.DPX** (this one is for indexing).

In you would like to move/delete a telephone list you created, you must move/delete all three files. Before you do any of this two operations, you must exit DeskTools.

## Glossary List (DeskTools Document)

A DeskTools document. This document is used to store chunk of text up to 4K each. It could be used to maintain a list of telephone conversations, contacts, summaries, book reports, memos, etc.

You can store diskette information and then print diskette labels.

The number of records is limited only by the size of your hard disk.

Any glossary list document **MUST** have extension **.GLS.** For each glossary file DeskTools generates two additional files with the same name and extensions **.DTG** (this one has the actual data) and another one with extension **.DGX** (this one is for indexing).

In you would like to move/delete a glossary list you created, you must move/delete all three files. Before you do any of this two operations, you must exit DeskTools.

## Reminder List (DeskTools Document)

A DeskTools document. This document is used to maintain your appointments, alarms, calendars and to-do lists.

You can print your calendars in four different formats: daily, weekly, monthly and yearly.

You can set an unlimited number of alarms. You can repeat events daily, weekly, monthly and yearly.

The number of records is limited only by the size of your hard disk.

Any reminder list document **MUST** have extension **.REM.** For each reminder file DeskTools generates two additional files with the same name and extensions **.DTR** (this one has the actual data) and another one with extension **.DRX** (this one is for indexing).

In you would like to move/delete a reminder list you created, you must move/delete all three files. Before you do any of this two operations, you must exit DeskTools.

## **Text Document (DeskTools Document)**

A DeskTools document. This document is used to basic word processing. You can type up to 32K size documents, change fonts, change word wrapping, find, replace, undo, cut, copy and delete.

The purpose is mainly to offer you a rapid way to type a small amount of text without all the overhead of the big word processors.

### Date & Time:

You must select the date and time at which the reminder will start and at which it will end.

#### Category:

In this version DeskTools keeps track of the category selected but does not do anything useful with it. We are open to suggestions from registered users as to how to use this option.

#### Alarm:

Set the alarm by checking the box. You can also select a number (0 to 59) of minutes the alarm will go off beforehand. The time at which the alarm will go off is defined by the **From Time**. For example, if the **From Time** shows 11:35 PM and you select the alarm to go off 3 minutes beforehand, the alarm will go off at 11:32 PM. A message box will pop up showing you the reminder and the time. If DeskTools is minimized, it is restored to its original position, and the reminder list shows the current date.

**Important Note:** For the alarm to go off the file which contains the record must be open.

#### Repeat:

Click this button if you wish to repeat this reminder. See help item <u>How to repeat an</u> <u>event</u>

#### Shortcuts

## **Delete command (Reminders menu)**

Use this command to delete an item from the list. The item must be highlighted before the command can take place. A message box asks for confirmation on the deletion. Although the message box says that this action is undoable, as long as you do not save your changes you still have your previous item in the file. To go back, just close the file and answer **NO** when asked if you want to save the changes made.

### Shortcuts

Keys: CTRL+B

# Find command (Reminders menu)

Use this command to find item(s) in the list. The items found will be displayed in the list. Double-click on an item to go to where that item was defined.

## Shortcuts

Keys: CTRL+C

# Add command (To-do menu)

Use this command to add a new item to the list. Select the priority for each task you wish to add. You can have the same priority for different tasks.

### Shortcuts

Keys: CTRL+J

# Delete command (To-do menu)

Use this command to delete an item from the list. The item must be highlighted before the command can take place.

### Shortcuts

Keys: CTRL+K

# Check command (To-do menu)

Use this command to check item in the list. A checked item means that you did it already. You can change the color of both your items in the list and your checked items by using the **Preferences** command.

## Shortcuts

Keys: CTRL+I

# Previous command (Calendar menu)

Use this command to go to the previous day, week, month or year. The least you can go is 1/1/1970.

## Shortcuts

Keys: CTRL+G

# Next command (Calendar menu)

Use this command to go to the next day, week, month or year. The most you can go is 12/31/2038.

## Shortcuts

Keys: CTRL+H

# Today command (Calendar menu)

Use this command to show today's date.

# Shortcuts

Keys: CTRL+T

## Export File command (File menu)

DeskTools allows you to export only Telephone and Glossary lists. Once a Telephone or Glossary list is opened and at least one item is entered in the list, the **EXPORT FILE** command shows up in the **FILE** menu.

Use this command to export the file to text format or to a database format. The database format is used mainly if you want to import the exported file into another program. Select the fields you wish to export, press export, and then select the name of the file you wish to save the exported file. It is recommended you add the extension **.TXT** to this new file.

### Shortcuts

Keys: CTRL+E

### Import File command (File menu)

DeskTools allows you to import only Telephone and Glossary lists. Once a Telephone or Glossary list is opened the **IMPORT FILE** command shows up in the **FILE** menu.

Use this command to import a file. Select the fields you are importing, select the delimiters for fields and records, press import, and then select the name of the file you wish to save the imported file.

## Status Bar command (View menu)

Use this command to display and hide the Status Bar, which describes the action to be executed by the selected menu item or depressed toolbar button, and keyboard latch state. A check mark appears next to the menu item when the Status Bar is displayed.

The status bar is displayed at the bottom of the DeskTools window. To display or hide the status bar, use the Status Bar command in the View menu.

The left area of the status bar describes actions of menu items as you use the arrow keys to navigate through menus. This area similarly shows messages that describe the actions of toolbar buttons as you depress them, before releasing them. If after viewing the description of the toolbar button command you wish not to execute the command, then release the mouse button while the pointer is off the toolbar button. This area also shows how many items are showing in the list (visible) and how many items are in the entire file.

The middle area shows the current date and time.

The right areas of the status bar indicate which of the following keys are latched down:

#### Indicator Description

CAP	The Caps Lock key is latched down.
NUM	The Num Lock key is latched down.

# Cascade command (Window menu)

Use this command to arrange multiple opened windows in an overlapped fashion.

# Tile command (Window menu)

Use this command to arrange multiple opened windows in a non-overlapped fashion.

# Tile Horizontal command (Window menu)

Use this command to vertically arrange multiple opened windows in a non-overlapped fashion.

# Tile Vertical command (Window menu)

Use this command to arrange multiple opened windows side by side.

# Window Arrange Icons Command

Use this command to arrange the icons for minimized windows at the bottom of the main window. If there is an open document window at the bottom of the main window, then some or all of the icons may not be visible because they will be underneath this document window.

# 1, 2, ... command (Window menu)

DeskTools displays a list of currently open document windows at the bottom of the Window menu. A check mark appears in front of the document name of the active window. Choose a document from this list to make its window active.

## Index command (Help menu)

Use this command to display the opening screen of Help. From the opening screen, you can jump to step-by-step instructions for using DeskTools and various types of reference information.

Once you open Help, you can click the Contents button whenever you want to return to the opening screen.

# Using Help command (Help menu)

Use this command for instructions about using Help.

## About command (Help menu)

Use this command to display the copyright notice and version number of your copy of DeskTools.

If you have not registered yet, and would like to do so please read the section <u>How to</u> <u>Register.</u>

If you registered your copy of DeskTools and received your name and code from us, press the button **Register.** Type your name as it was given to you. This is case sensitive. Then type your code and press ENTER. Your name will show up now in the About Box.

If it did not show up in the about box, check that your name and code are typed **exactly** the same way it was given to you and try again. If it still does not work contact us.

## **Context Help command**

Use the Context Help command to obtain help on some portion of DeskTools. When you choose the Toolbar's Context Help button, the mouse pointer will change to an arrow and question mark. Then click somewhere in the DeskTools window, such as another Toolbar button. The Help topic will be shown for the item you clicked.

## **Title Bar**

The title bar is located along the top of a window. It contains the name of the application and document.

To move the window, drag the title bar. Note: You can also move dialog boxes by dragging their title bars.

A title bar may contain the following elements:Application Control-menu button

- Document Control-menu button
- Maximize button .
- Minimize button .
- Name of the application .
- Name of the document
- Restore button .

# Scroll bars

Displayed at the right and bottom edges of the document window. The scroll boxes inside the scroll bars indicate your vertical and horizontal location in the document. You can use the mouse to scroll to other parts of the document.

# Size command (System menu)

Use this command to display a four-headed arrow so you can size the active window with the arrow keys.

÷

After the pointer changes to the four-headed arrow:

- 1. Press one of the DIRECTION keys (left, right, up, or down arrow key) to move the pointer to the border you want to move.
- 2. Press a DIRECTION key to move the border.
- 3. Press ENTER when the window is the size you want.

Note: This command is unavailable if you maximize the window.

## Shortcut

Mouse: Drag the size bars at the corners or edges of the window.

# Move command (Control menu)

Use this command to display a four-headed arrow so you can move the active window or dialog box with the arrow keys.

Note: This command is unavailable if you maximize the window.

## Shortcut

Keys: CTRL+F7

# Minimize command (application Control menu)

Use this command to reduce the DeskTools window to an icon.

Mouse: Click the minimize icon 🔽 on the title bar. Keys: ALT+F9

# Maximize command (System menu)

Use this command to enlarge the active window to fill the available space.

#### Shortcut

Mouse: Click the maximize icon on the title bar; or double-click the title bar. Keys: CTRL+F10 enlarges a document window.

# Next Window command (document Control menu)

Use this command to switch to the next open document window. DeskTools determines which window is next according to the order in which you opened the windows.

#### Shortcut

Keys: CTRL+F6

# Previous Window command (document Control menu)

Use this command to switch to the previous open document window. DeskTools determines which window is previous according to the order in which you opened the windows.

#### Shortcut

Keys: SHIFT+CTRL+F6

## **Close command (Control menus)**

Use this command to close the active window or dialog box.

Double-clicking a Control-menu box is the same as choosing the Close command.



Note: If you have multiple windows open for a single document, the Close command on the document Control menu closes only one window at a time. You can close all windows at once with the Close command on the File menu.

#### Shortcuts

Keys: CTRL+F4 closes a document window ALT+F4 closes the DeskTools application instance

# **Restore command (Control menu)**

Use this command to return the active window to its size and position before you chose the Maximize or Minimize command.

## Switch to command (application Control menu)

Use this command to display a list of all open applications. Use this "Task List" to switch to or close an application on the list.

#### Shortcut

Keys: CTRL+ESC

#### **Dialog Box Options**

When you choose the Switch To command, you will be presented with a dialog box with the following options:

#### Task List

Select the application you want to switch to or close.

#### Switch To

Makes the selected application active.

#### **End Task**

Closes the selected application.

#### Cancel

Closes the Task List box.

#### Cascade

Arranges open applications so they overlap and you can see each title bar. This option does not affect applications reduced to icons.

#### Tile

Arranges open applications into windows that do not overlap. This option does not affect applications reduced to icons.

### Arrange Icons

Arranges the icons of all minimized applications across the bottom of the screen.

Ruler command (View menu)

# Choose Font dialog box

Select a family, size and a style. Click OK. This settings are particular to each file.

# Choose Color dialog box

Press the button **Define Custom Colors.** Select the color you want to change, select the new color. Now, click on **Add Custom Color.** Click OK to save your changes.

# Find command (Edit menu)

Type the word you wish to search for. Click **Find.**

# Repeat command (Edit menu)

Use this command to repeat the last **Find** command carried out.

#### How to edit a record

To edit a record that already exists in one of the lists, just double-click on the item and a dialog box with all the information will pop-up. Make any changes you wish to make on this item and then press **Add** or simply hit ENTER. If you do not wish to make any changes just press the **CANCEL** button or hit the ESC key.

#### How to dial out

Once you have items in your telephone list, select one so that the information of such item is displayed in the dialog box fields. If you have a phone number in one of the boxes named **Home, Work,** and **Fax** just press the button of the number you wish to dial.

If your settings are correct a message box will pop-up showing you the number you are dialing and asking you to pick up the receiver. Once you pick up the receiver press ENTER or click on the OK button. Your connection has been established.

If your settings are not correct, check them out using the <u>Set Dial Settings</u> command.

## How to set headers and footers

Some pages such as text documents, phone directories, glossary lists have the option of showing a particular header and footer on each page.

Accelerators for certain options are:

- &f file name
- **&p** page number

By selecting a header like **&f** and a footer like **Page &p** you will get the name of the file on the upper left corner, the time (file or system) on the upper right corner and the page number on the center bottom of each page.

Have empty boxes for the header or/and footer in case you do not want one of them.

## How to repeat an event

In order to repeat an event/reminder, press the **Repeat** button in the **Add Item Dialog Box** for reminders. A dialog box will pop-up asking you to select:

### How often you want to repeat the reminder:

Select daily, weekly, monthly (by day or by weekday) and yearly (by day or by weekday).

#### Select until when you want to repeat such event:

This date must be greater than the initial date you started with.

Press the **Repeat** button. Now click on the **Add** button to add or edit this reminder. A watchclock will show you that DeskTools is busy repeating your event.

#### How to set an alarm

To set an alarm for a particular reminder make sure your **From Date** is already set. The alarm time depends on this one. Check the box **Set Alarm** and if you wish, select a number of minutes (between 0 and 59) which you want the alarm to go off beforehand. Click on the **Add** button. A reminder with alarm will show an A in parenthesis in the list of reminders: **(A)**.

Once the alarm goes off, by displaying the reminder in a message box, the **(A)** will disappear from the reminder item.

# Select All (Data menu)

Select the entire document.

# Word Wrap (Data menu)

Use this command to force text to wrap around the window's frame. If this command is unable then a horizontal scroll bar allows you to see the document once it goes past the right hand side part of the window.

# Set Tab Stops (Data menu)

Define how many spaces for each tab. Default is 8 spaces.

# Set Printer Font (Data menu)

Define font to be used by your printer. This selection will be saved when you save your file.

# Mirror Display Font (Data menu)

This command makes the font used for the screen display the same as the font used to print documents.

# Print command (File menu)

Use this command to print a document. This command presents a <u>Print dialog box</u>, where you may specify the range of pages to be printed, the number of copies, the destination printer, and other printer setup options.

# Print dialog box

The following options allow you to specify how the document should be printed:

#### Printer

This is the active printer and printer connection. Choose the Setup option to change the printer and printer connection.

## Setup

Displays a <u>Print Setup dialog box</u>, so you can select a printer and printer connection.

### **Print Range**

Specify the pages you want to print:

**All** Prints the entire document.

**Selectio** Prints the currently selected text.

**Pages** Prints the range of pages you specify in the From and To boxes.

### Copies

Specify the number of copies you want to print for the above page range.

### **Collate Copies**

Prints copies in page number order, instead of separated multiple copies of each page.

### **Print Quality**

Select the quality of the printing. Generally, lower quality printing takes less time to produce.

# Print Progress Dialog

The Printing dialog box is shown during the time that DeskTools is sending output to the printer. The page number indicates the progress of the printing.

To abort printing, choose Cancel.

### **Print Preview command (File menu)**

Use this command to display the active document as it would appear when printed. When you choose this command, the main window will be replaced with a print preview window in which one or two pages will be displayed in their printed format. The <u>print preview toolbar</u> offers you options to view either one or two pages at a time; move back and forth through the document; zoom in and out of pages; and initiate a print job.

# **Print Preview toolbar**

The print preview toolbar offers you the following options:

# Print

Bring up the print dialog box, to start a print job.

## Next Page

Preview the next printed page.

## Prev Page

Preview the previous printed page.

## One Page / Two Page

Preview one or two printed pages at a time.

## Zoom In

Take a closer look at the printed page.

## Zoom Out

Take a larger look at the printed page.

## Close

Return from print preview to the editing window.

# Print Setup command (File menu)

Use this command to select a printer and a printer connection. This command presents a <u>Print Setup dialog box</u>, where you specify the printer and its connection.

## Print Setup dialog box

The following options allow you to select the destination printer and its connection.

## Printer

Select the printer you want to use. Choose the Default Printer; or choose the Specific Printer option and select one of the current installed printers shown in the box. You install printers and configure ports using the Windows Control Panel.

# Orientation

Choose Portrait or Landscape.

#### Paper Size

Select the size of paper that the document is to be printed on.

#### **Paper Source**

Some printers offer multiple trays for different paper sources. Specify the tray here.

#### Options

Displays a dialog box where you can make additional choices about printing, specific to the type of printer you have selected.

## Network...

Choose this button to connect to a network location, assigning it a new drive letter.

## Page Setup command (File menu)

Some pages such as text documents, phone directories, glossary lists have the option of showing a particular header and footer on each page.

Accelerators for certain options are:

- &f file name
- **&p** page number

By selecting a header like **&f** and a footer like **Page &p** you will get the name of the file on the upper left corner, the time (file or system) on the upper right corner and the page number on the center bottom of each page.

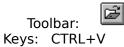

# Print Compact Directory command (File menu)

Use this command to print a compact directory. This directory will print your phone numbers only in two column format. You can select Portrait or Landscape mode.

For best results select a Font of size no greater than 10. However, you can try different options and decide on the best one for your particular printer.

Use this command to print a expanded directory. This directory will print your phone numbers only in a one column format. You can select Portrait or Landscape mode.

Top: For matrix printers this value is usually 0. For laser printers this value is usually 0.5 (half an inch).

### Print:

Select the fields you wish to show in your envelop as well as the appropriate address.

### **Select Alignment:**

Check either left aligned or center aligned for the address.

### **Return Address:**

Enter here your return address. You can select a different font for the return address

by

pressing the Set Return Address Font button.

### Select Return Address Alignment:

Check either left aligned or center aligned for the return address.

### Print:

Select  $% \left( {{\mathbf{F}}_{\mathbf{F}}} \right)$  the entire list or the selected item only. If you select  ${\mathbf{Selected}}$  item and there is no

one selected, then by default the first one in the list is printed.

Once this settings are defined they are saved with the file for future printing, so next time you wish to print envelopes your settings are already defined. However, this settings are particular to this file. If you open a new Telephone List you must define your settings again.

### **Before Printing:**

Make sure you select the  $\ensuremath{\textbf{Print Setup}}$  command before printing and select the following

options: landscape, manual feed and envelopes.

In Between Rolodexes:	This is the space between labels vertically.	
	For matrix printers this is usually 1/16.	
	For laser printers this is usually 0.	

#### Print:

Select the entire list or the selected item only. If you select  $\ensuremath{\textbf{Selected Item}}$  and there is no

one selected, then by default the first one in the list is printed.

Once this settings are defined they are saved with the file for future printing, so next time you wish to print labels your settings are already defined. However, this settings are particular to this file. If you open a new Telephone List you must define your settings again.

In this format DeskTools will print all the information there is for each particular record. This is the only way (other than exporting to text) to print all fields in the database for each record.

# Print Yearly Calendar command (File menu)
