

## ***What is Shareware?***

GoCIS is NOT public domain or free software, but is being distributed as "shareware".

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details -- some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocketbook, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee -- if you don't use the product, you don't pay for it.

## ***Registration Information***

GoCIS is currently being marketed as shareware. If you register GoCIS you will receive these remarkable benefits:

- An end to the registration reminder screens
- Unlimited free technical support.
- A Valuable Fast Find Forum program.
- Discounts on the next major version of GoCIS

The Registration fee for GoCIS is \$59.95 (US funds) per license + \$6.00 shipping and handling in North America (\$9.00 outside of North America). We accept VISA, MasterCard, money orders, checks, or purchase orders (call beforehand). Quantity pricing and LAN pricing is available.

You can order GoCIS through the mail, or by using CompuServe.

To order GoCIS using either method, please make use of the online order form facility built into GoCIS. You can access the order facility by selecting the **Help** menu item and then selecting the *Order GoCIS Now* topic. This will present a window that allows you to select *Print an Order Form* or *Order Now on CompuServe*. Press the desired button.

If you press *Print an Order Form*, you will be presented a window to enter your name, address and other information into. The order form will then be printed, ready to mail.

If you press *Order Now on CompuServe*, you will be presented with a window describing the process GoCIS will use to order using CompuServe. You will be asked to confirm your intentions. If you agree, GoCIS will dial CompuServe and place the order for you. CompuServe will include the registration fee in your next month's CompuServe charges.

# **GoCIS License Agreement**

***GoCIS is not, and has never been, public domain software, nor is it free software.***

Your use of GoCIS indicates your acceptance of the following terms and conditions:

## **1. License**

Non-registered users of GoCIS are granted a limited, single user license, to use GoCIS on a 30-day trial basis, solely for the express purpose of determining whether GoCIS is suitable for their needs. The use of GoCIS, except for the initial 30-day trial, requires registration. The use of unlicensed copies of GoCIS, outside of the initial 30-day trial, by any person, business, corporation, government agency or any other entity is strictly prohibited.

A single user license permits you to use the program on different computers, but may not use the program on more than one computer at the same time.

You may not modify, patch, decompile, disassemble or otherwise reverse engineer the program.

## **2. Copyright**

GoCIS is owned by Logix Systems and is protected by United States copyright laws and international treaty provisions. You may not use, copy, modify, or transfer the program, or any copy, except as expressly provided for in this agreement. You may not copy the documentation except as expressly provided for in this agreement.

A limited license is granted to copy and distribute GoCIS only for the trial use of others, subject to the above limitations, and also the following:

- 1) GoCIS must be copied in unmodified form, complete with the file containing this license information.
- 2) The full machine-readable GoCIS documentation must be included with each copy.
- 3) GoCIS may not be distributed in conjunction with any other product without a specific license to do so from Logix Systems.
- 4) No fee, charge, or other compensation may be requested or accepted, except as authorized below:
  - A) Operators of electronic bulletin board systems (sysops) may make GoCIS available for downloading only as long as the above conditions are met. An overall or time-dependent charge for the use of the bulletin board system is permitted as long as there is not a specific charge for the download of GoCIS.
  - B) Vendors of user-supported or shareware software approved by the ASP may distribute GoCIS, subject to the above conditions, without specific permission. Non-approved vendors may distribute GoCIS only after obtaining written permission from Logix Systems. Such permission is usually granted. Please write for details (enclose your catalog). Vendors may charge a disk duplication and handling fee, which, when pro-rated to the GoCIS product, may not exceed eight dollars.

## **Corporate/Site Licenses**

All corporate, business, government or other commercial users of GoCIS must be registered. We offer quantity discounts as well as site licensing.

Site licensing agreements allow duplication and distribution of specific number of copies within the licensed institution. Duplication of multiple copies is not allowed except through execution of a licensing agreement. Site license fees are based upon estimated number of users.

Corporate licensing agreements allow unlimited duplication, distribution and use of GoCIS within the licensed institution.

With a site or corporate license, only one copy of the program and the printed manual will be sent. You will be responsible for distributing additional copies. Additional printed manuals may be ordered separately.
