PHILOSOPHY OF BUDGET MANAGER:

The basic philosophy of BUDGET MANAGER is to assign all general funds money (excluding savings, investments, etc.) to a particular Fund (such as food, auto, income, telephone) to help record and control spending, and also to a particular Account (such as checking, cash, Visa) where the money actually resides (or is owed to, in the case of charge or credit cards).

Each month there is a budget which takes money from funds which are sources of income (such as salary or interest income) and moves it into fund representing expenses (rent, food, taxes, etc.). Since money cannot be created or destroyed, your budget must balance, (that is, your income = your expenses) before BUDGET MANAGER will let you enter transactions. If you have more income than expenses, you can always budget less income (which will give you a buffer in the income funds), or increase savings (a fund representing money in your general funds which is intended to be moved to a savings account). Unfortunately, more people are likely to have the opposite problem--the expenses you would like to support exceed your income. Then you must prioritize and cut expenses until they match your income. That will give you a balanced budget.

GETTING STARTED:

If you have used a previous version of BUDGET MANAGER, see the topic BUDGET MANAGER CONVERSION.

Otherwise, the first thing you will want to do is enter several funds and accounts. See the topic FUNDS AND ACCOUNTS for a list of suggestions. There are also some sample budgets which you can modify--use 'Open' from the 'File' menu and select one of the SAMPLE?.BGT files. You can change the names of Funds and Accounts, plus add new ones or delete unwanted ones using the items under the 'Budget' menu. Since deleted Funds and Accounts aren't removed from the budget until the 'New Year' command is used, it is best to change names rather than add some and delete others. When you have made your modifications, select 'SaveAs' from the 'File' menu and name the file "CURRENT.BGT". Then the next time you run BUDGET MANAGER that file will load automatically.

The next step is to initialize the various balances. If you are transferring from another system, it may be easiest to use the 'Adjust Fund' and 'Adjust Account' transactions. This is likely the only time you will ever use these options, since these do not preserve the budget system, which has all money in both a Fund and an Account. If you ever use these transactions, you will want to make sure that the totals for all Funds and all Accounts match when you are finished.

If you are starting from scratch, it will probably be easiest to do a deposit transaction into your INCOME fund for each of your accounts (checking accounts, cash on hand, etc.) for the amount that each has. When your next credit card bills come in, use a debit transaction from the INCOME Fund and the credit card Account for any charges which are not entered in your budget. For each of these transactions, you can use some description such as "Beginning". As you later discover additional Funds you need, you can always add them then.

When you are beginning, you may not know how much to budget for each Fund. You can use BUDGET MANAGER to record spending for a few months, and at the end of each month, set the Budget amount for each Fund equal to the amount the Fund changed during that month. Change the budget amount of the Income fund to balance the budget. After your spending patterns are fairly clear, you can use the information to set budget goals, and then use the goals to help make decisions about spending. It is not necessary for the amount spent every month to equal the amount budgeted. Normally some Funds will have positive balances and others negative balances each month. The important thing is that no Fund becomes too negative and that the total of the non-Income Funds stays positive.

FUNDS AND ACCOUNTS:

Some suggested Funds are: Auto, Charity, Clothing, Education, Electric, Entertainment, Food, Gas, Gifts, Household, Income, Insurance, Laundry, Medical, Miscellaneous, Personal Care, Phone, Rent (or House Payment), Savings (i.e. Money set aside to be put into a savings account or invested), Taxes (if your budget is based on gross pay rather than net pay).

Some suggested Accounts are: Cash, Checking (one for each bank), Visa etc. (one for each card). If you want to record a bank savings account also, you will probably want to create a special Fund (such as SAVED) which always has the same balance as your savings account. Then when you make deposits from a checking account, you can record an Account transfer (Checking account to Savings account) and a Fund transfer (SAVINGS to SAVED). Or you can keep all Savings account records separately.

BUDGETS:

Monthly Budgets remove money from some Funds (sources of income) and add money to other Funds. You determine the amounts using 'Change Budget Amount' under the 'Budget' menu. When you change the amount, you also have the option of using the same amount for later months. That box starts checked beginning in the current month, and starts unchecked in all previous months.

Since money can't come out of nowhere, the Budget must balance before you can record new transactions or begin a 'New Year'. To set Budgets, take your average monthly income (yearly salary/12) for the budgeted Income, enter fixed expenses and priority items, and adjust items until the budget balances. Try to budget for monthly averages--for example, one sixth of your six month car insurance payment should be budgeted for each month. Then by the time your next payment rolls around, you will already have the money for it. When setting up a budget originally, it may be necessary to begin with some money in funds with irregular expenses (such as insurance).

TRANSACTIONS:

You should record all spending, withdrawals, deposits, charges, payments, interest payments, and everything which affects the balance of any Fund or Account. The means of recording these is by using Transactions from the menu of BUDGET MANAGER. Anything which subtracts from both a Fund and an Account is a Spending/ Debit Transaction. Anything which adds to a Fund and an Account is a Deposit. You can also transfer between Funds or Accounts (the latter would be for credit card bills, or cash withdrawals from checking).

For any transaction, select the affected Fund(s) and/or Account(s) from the dialog box, enter the amount (it should always be positive, except for Adjustments, which should be avoided). You may also enter a short note. The date is important--transactions are sorted by date. When everything is correct, select OK or press return (when the OK button is outlined).

Transactions can be deleted by clicking the right mouse button while the cursor is on top of the listing (use View with any of the transaction listings). No deletions or new transactions are permitted for records of old years (created by 'New Year') or if a Fund or Account which has been deleted is involved.

Transactions can be marked or unmarked by clicking the left mouse button. This is true even for files in old months, and is intended to help when balancing checking account and credit card statements. A mark means that the transaction has cleared the bank or card company.

NEW YEAR:

BUDGET MANAGER holds up to 15 months worth of data at one time. So at the end of every year, after all of the transactions for that year have been entered, you must instruct BUDGET MANAGER to take the data for the year and put it into an archive file. You can always view or print the information, but cannot change it (except for marking transactions). It will then take the data after the end of the year (the remaining 3 months) and move it to the beginning of the file. After the end of the year, BUDGET MANAGER will remind you that you need to do this every fifth time you start up the program.

The command which does all of this is 'New Year', located under the 'Budget' menu. Before processing a 'New Year' command, you should audit your budget (i.e. check to see that the amounts listed by BUDGET MANAGER for your cash accounts and checking accounts agree with your cash-on-hand and your check book). That way, if a discrepancy is found, you have an opportunity to correct it before the record becomes permanent. Do not worry too much if there is sometimes a small amount of cash missing. You likely forgot to enter a cash transaction, and you can correct it by entering a debit from Miscellaneous with the description "missing cash". It would be useful to both audit your budget and review budgeted amounts several times a year.

When you select 'New Year', a dialog box will open. This is your chance to cancel if not all transactions have been entered. If all have been entered, select the first month of the new year, and click on 'Ok'. You will be prompted for the name of the file for the old year. The new year will have the same file name that you started with. If you decide you should not have used the 'New Year' command after you have done it, quit without saving. If you have already saved the file once but not twice, you can still find the original file with the old file name and the extension '.BAK'.

The default month is one year later than the first month of the current file. When BUDGET MANAGER creates a new file, the first month is always January of the current year. So if you budget by calendar year, everything will be done automatically. If, however, you use a fiscal year different from the calendar year, this is your opportunity to change that. When you are asked for the first month of the new year, select the first month of your fiscal year. You may have to change the year as well as the month. Then BUDGET MANAGER will save a partial year under whatever name you choose, and you will be left with a file starting at the beginning of your fiscal year. Prompting for the next 'New Year' command will begin at the end of your fiscal year, not the calendar year.

Version 2.0 contained a bug which computed the starting balances

incorrectly, and mixed up some fund and account names when funds and accounts were deleted. This has been corrected in this version. See the topic [Version 2.0 Bug Fix](#) if you need to repair a data file.

VIEWING AND PRINTING:

Viewing and Printing are very similar operations. Each starts with the selection of one of the options under the 'View' menu.

You can view all of the Funds with their starting balance (i.e. balance at the start of the month), the amount budgeted for the month, how much the balance has changed so far this month, and the current balance. The next option is the same information (except for budgets) for all Accounts. The third option shows spending patterns for the year to date for the various Funds.

Then there are three options for displaying transactions: all transactions, those involving a particular Fund, and those involving a particular Account. You will be prompted for the particular Fund or Account on the latter options. The information will be displayed on your screen, and you can scroll down using the mouse to portions which are out of sight. The 'Home', 'End', 'Page Up', 'Page Down', up arrow and down arrow keys also affect the position of the scroll bar.

You may also look at just the transactions which have been marked. To see all marked transactions, select 'Only Marked Transactions' from the 'View' menu. To see all marked transactions for a particular Fund or Account, first view those transactions as described above, then select 'Only Marked Transactions' under 'View'. To see all transactions again, simply select the view you wish to see again. If you mark certain transactions for the purpose of viewing or printing (see below) only a portion of the transactions, you may wish to save the file before marking them differently than you normally do. A similar option is available for viewing only unmarked transactions.

Only information from one month is displayed at one time (except for viewing transactions involving a particular Fund or Account with 'ANY' months selected). To view information from a different month, use the left and right arrow keys to see the previous and next month, respectively. When viewing 'Year-To-Date' or 'ANY' months with a particular Fund or Account, the totals will depend on the current month.

To print information, first select it using the 'View' menu as described above. Then choose 'Print' under the 'File' menu. A printer dialog will pop up and you can select your printer and resolution. Then it should print using the Windows Print Manager.

REMINDERS:

You may set up reminder notices to remind you of upcoming payments due or any other message. Select the 'Reminder' menu and choose 'New' to create a new reminder or 'Edit Existing' to review and edit whatever reminders are already there. Enter your message (up to 79 characters) in the space provided, and set the date on which you wish reminder messages to begin appearing. For example, if the phone bill is due on June 19, you may wish to be reminded beginning June 14. Reminders appear when you first open the file (the file CURRENT.BGT opens when you start BUDGET MANAGER), so if you do not run the program every day, be sure to leave enough time to see your message before the bill is due.

If your rent or house payment is due the 20th of every month, you can set up a permanent reminder which will begin reminding you every month on the 15th. Simply select 'ANY' for the month and enter 15 for the day. The year is irrelevant in this case. Then every month, on or after the 15th, the reminder message will appear. When everything is as you want, select one of the buttons at the bottom which begins with 'OK'. You have the option of finishing editing the reminders; going on to another, new, reminder; or editing the next or previous existing reminder. You can also choose 'Cancel' (which leaves the current reminder unchanged, or deletes it if the message is blank) or 'Delete' (which deletes the current message). The check box 'Turn Reminder On' is intended for the monthly reminders primarily, but any reminder can be turned off. New reminders start turned on. You normally will not have to change that box, as monthly reminders are turned on automatically on the first of the month.

When a reminder message appears on your screen, you have four options. You can have it remind you the next time by clicking on 'Remind Again' or just pressing the 'Enter' key. If you will not need the reminder again, you can click on 'Delete'. For monthly reminders you will not need until the next month, select 'Reminder Off'. If you want the reminder to come on again two weeks after its starting date (say, to remind you of biweekly direct deposits), you can select 'Reset 2 Weeks Later'.

At the first of every month, all reminders will be automatically turned on again. Any old dated reminders will appear at that time to remind you to delete them. Any monthly reminders which were still on at the end of the previous month will appear one time in the new month, even though it may be before the date on the reminder. Reminders only work for files which are not locked (locked files are the archive files created by 'New Year').

PASSWORDS:

BUDGET MANAGER has passwords to help preserve the privacy of your finances. By default, the password is "Password". If you never change the password, that will automatically give you access to all your files.

If you do change your password (using 'Change Password' under 'File'), BUDGET MANAGER will prompt you for the password on the file CURRENT.BGT when it begins. It will then use that password on all files until you change it. If you open an old file with a different password, it will prompt you for the password on that file. (Remember that the default is "Password"). If you do not know a password and press 'Cancel', BUDGET MANAGER erases the information from memory (but it is still on the disk). DO NOT FORGET YOUR PASSWORD! There is no way to read a file if you do not know the password. Note that the password is case sensitive, so that "Password", "password", and "PASSWORD" are all different.

KEYBOARD SHORTCUTS:

As with many Windows programs, there are a number of keyboard shortcuts you can use. Everything can of course be done with the mouse, and when you are learning the program, it will be easiest to use the mouse. However, it is not always fastest to open up every menu item with the mouse. Every menu item can be accessed by holding down the 'Alt' key and typing the letter in the desired menu which is underlined. Some items can be accessed by pressing just one or two keys.

The function keys F1-F4 control the viewing functions. F5-F8 bring up transaction dialog boxes. F9 changes budget amounts, F10-F11 add funds or accounts (useful for setting up the budget system), and F12 brings up the note page. Each of these are listed to the right of the associated menu item when you do use the mouse, so the ones you use often you will see. Open, Save, Print and Exit also have shortcuts. The usual Help shortcut, F1, was programmed to bring up the Fund View in versions before this Windows Help file was added. To get Help, you can press 'Ctrl' and F1. Up and down arrow keys, 'Home', 'End', 'Page Up' and 'Page Down' all control the scroll bars. Left and Right arrow keys change the current month displayed.

You can also use the 'Tab' key to navigate dialog boxes, and can access particular selections from a list by pressing repeatedly the first letter of the desired item until it is selected.

Some things you cannot do without the mouse. Selecting transactions to be marked or deleted requires the mouse to be positioned on the desired transaction, and the left or right button, respectively, to be pressed. When changing budget amounts, the check boxes require the mouse as well. You can, however, enter a negative number for the budget amount. That has the effect of reversing the Source of Income check box.

BUDGET MANAGER CONVERSION:

If you have used a version of BUDGET MANAGER older than version 2.0, you will need to use the CONVERSION program CONVERT.EXE to make your files readable to BUDGET MANAGER version 2.1. Since version 2.1 will hold up to 15 months worth of data, CONVERT.EXE can load up to that many old files, combine the information, and save the combined file in the new format. You can also use CONVERT.EXE to fix problems caused by a bug in the 'New Year' command of version 2.0.

If you have used more than 140 Funds or 45 Accounts total between the different monthly files, BUDGET MANAGER CONVERSION will combine Funds or Accounts of your choosing. This feature, which is not available in BUDGET MANAGER itself, may prove useful to someone who has not used previous versions of BUDGET MANAGER.

When you first start the conversion program, it asks you for the first month of the new yearly file, suggesting January of the current year. Begin with whatever month your fiscal year starts in. Then add the files created by the previous version of BUDGET MANAGER. The program distinguishes between the first file in the year ('Add First File in Year') and other files in the year ('Add Other File in Year'). The only difference between them is that the first file determines the starting balances of the Funds and Accounts for that year. If you discover you have entered a later file as the first file, you can correct it by loading the first file as the first file.

There are several options available for how a file is added, depending on how you wish to use the information in the file. The month tells CONVERSION which month to place the budget data in. The default month is the first month which doesn't already have budget data loaded. For this reason, it is most convenient to load January (or the first month of the fiscal year) first, and then February, March, etc. Starting balances are used only for the first file in the year (see previous paragraph). The budgets for the funds can be used in the month selected only, in the month selected and all future months, or not at all. Transactions are normally added to the file, but may be ignored. Reminders are normally added to the file, but may be ignored. If a file had been locked, it has no reminders, so this option will usually have no effect. The primary purpose for the last two options is to correct for adding the file CURRENT.BGT without using the budget for future months. In this case one can reload the file, ignore transactions and reminders, and apply the budget to later months as well. The option to ignore the budget is primarily to correct for adding the first file using the 'other file' option. One can reload the file as the first file, but ignore the budget, transactions, and reminders. If the wrong file is loaded as the 'first file', simply load the correct first file as the first file, ignoring budgets, transactions, and reminders

if it was loaded before.

VERSION 2.0 'NEW YEAR' BUG FIX:

BUDGET MANAGER version 2.0 has an error in the 'New Year' computations. The old year is saved correctly. But the new CURRENT.BGT file has a couple of different problems. The starting balances are figured incorrectly. Also, if any Funds or Accounts were deleted, transactions involving Funds or Accounts which come later in alphabetical order will no longer be correct. Here is how to fix these problems:

First, check if the file CURRENT.BGT or its backup CURRENT.BAK still has the old information in it. You have to save CURRENT.BGT twice after the 'New Year' command before it is lost. If one of these has the old data, simply use BUDGET MANAGER version 2.1 for the 'New Year'.

If both CURRENT.BGT and its backup are from after the 'New Year' command, run CONVERT.EXE (and hit enter for the default first month--that will not be important). Select the Correction menu item (Correct Version 2.0 New Year). First it will ask you to open the file from the old year. For instance, if you executed the 'New Year' command in January 1996, open the YEAR1995.BGT file. That will provide the information for the starting balances in 1996. Next the program will ask you to open the corrupted current year file. Open CURRENT.BGT (or, if you have made many changes, such as renaming or adding Funds and Accounts, the older version CURRENT.BAK may be preferable). Then CONVERT.EXE will fix the starting balances. The only difficulty would be if you changed names of Funds or Accounts since the 'New Year' command. It would be better to change any names back before trying to correct the file. If that cannot be done, you can enter Adjust Fund or Account transactions manually.

The harder part is fixing the transactions. If you haven't altered or added any Funds or Accounts, all of the old transactions can be fixed easily. All new transactions entered since the command are already fixed--the bug does not affect them. You will need to decide transaction by transaction whether it needs fixing. The program will display the transactions one by one, and suggest a correction if necessary. If it is an old transaction (entered before the 'New Year' command), and the corrections look right, click on the button labeled 'OK as corrected'. If it is an old transaction but some Funds or Accounts were added, renamed or merged, first make sure the correction is actually correct. If it is a new transaction (entered after the 'New Year' command), click on 'OK originally'. If you know that all remaining transactions are new ones, or if you are sure that no Funds or Accounts were deleted, you can click on 'All Transactions OK'. Next, if you decide that all transactions have been corrected, the program will reprocess all of the transactions from scratch, and everything should be fixed.

Check the balances and transactions to confirm that they have been corrected. If so, save the file as CURRENT.BGT. If not, save it as TEMP.BGT, and go through the process above again. This time, instead of loading the corrupt CURRENT.BGT, load the only partially corrupt TEMP.BGT. If only one or two transactions are wrong, it may be easier to use BUDGET MANAGER to delete them and re-enter the correct ones.

PROGRAM LIMITS:

There are limits of 140 Funds and 45 Accounts. If you discover that you need to add another after you have reached this limit (and deleted Funds and Accounts count toward this limit, since they are not truly deleted until the 'New Year' command), you can use the Budget Manager Conversion program (CONVERT.EXE) to merge two Funds or Accounts. Up to 200 transactions can be held in memory at one time, with all others being stored in temporary files on the hard drive. About 32,000 transactions can be stored on disk, but this will result in very slow operation. Fund and Account names are limited to 13 characters. The length of the transaction description varies according to the size of the transaction amount, with a maximum of 21 characters. There is only so much room on the screen, and 'View' 'All Transactions' uses it all. There are 20 reminder messages available. If the 79 character messages are not enough, you can always use the message to refer to a note on the Notes page. There is limited space on the Notes page, but it should be adequate. If you need more space, you can use the editor to open another file. Dollar amounts over about \$21 million are not handled correctly by the program. If this is a problem for you, you can afford a better program.

REGISTRATION:

After using this program for a period of 60 days, you must register it to continue using it. BUDGET MANAGER will print out a form for you to send in with your registration fee of \$10--see 'Register Copy of Program' under the 'File' menu item. Tutorial Instructions

This Tutorial will lead you through the steps to set up your budget. After you have followed the instructions on each page, select the highlighted "NEXT" at the bottom of the page. Use the scroll bar at the right to view the information at the bottom of this page. When you wish to leave the tutorial, select "EXIT TUTORIAL" at the bottom. If this window gets in your way, any window can be moved by holding the left mouse button and moving the cursor when it is on the title bar at the top.

Choose: NEXT, or
EXIT TUTORIAL

You will want to have BUDGET MANAGER running at the same time as this tutorial. If it is running but not visible, use Ctrl-Tab to bring it up. This window will remain on top. If it is not running, exit Help now, and run the tutorial from the Help menu of BUDGET MANAGER once it is running.

Tutorial Page 1

First we will enter some funds and accounts. We will start with the sample budgets. To open a sample budget file, position your cursor on the 'File' menu, press the left mouse button, and drag the cursor (without releasing the button) down until the 'Open' option is highlighted. Then release the button, and a list of budget files will be displayed. Double click on SAMPLE1.BGT.

Now display the fund names for this budget. Under the 'View' menu, select the option 'Fund Balances'. You can use the scroll bar on the right of your screen to see the names which are off the page. Now take a few moments to examine the other sample budgets, SAMPLE2.BGT and SAMPLE3.BGT. When you decide which is the closest to what you will need, open it and proceed to the next page, which will give instructions on how to customize it.

To customize the budget, you may change the names of Funds and Accounts, plus add new ones or delete unwanted ones using the options under the 'Budget' menu. Make any changes you wish to make now, and then go on to the next page. Modifications can be made at any later time as well.

Now that your modifications are done, you want to save the file using the name BUDGET MANAGER will look for. Select 'SaveAs' from the 'File' menu, and a menu will appear. Type the name "CURRENT.BGT" and click on the OK button. The next time you run BUDGET MANAGER your file will load automatically.

The next step is to initialize the various balances. We will begin by assuming all of your money is allocated to your INCOME fund (i.e. you have earned it, but haven't earmarked it for anything yet). Find a balance for all accounts except charge cards.

For each account, make a deposit transaction into your INCOME fund. Choose the 'deposit' option under the 'transaction' menu. You may find it useful to use the Tab key to move from region to region, and typing the first letter of the name will select funds and accounts. Repeat this for all of your non-charge card accounts.

Your budget is now customized and initialized. Now you are ready to start keeping your budget. Record all transactions as they occur. Special notes about charge card accounts and setting budgets follow on the next two pages.

A special note about charge card accounts is needed. Normally, when you charge something, it will be deducted from your charge card account. When you write a check to pay the bill, it will be recorded as an account transfer from your checking account to your charge card account. This will not work for any charges which are currently outstanding, however. In this case, when your credit card bills come in, use (a) debit transaction(s) from the appropriate Fund(s) and the credit card Account for any charges which are not entered in your budget. After a couple of months, all charges should be cleared, and your bills will all be transfers.

You can use BUDGET MANAGER to record spending for a few months, and at the end of each month, set the Budget amount for each Fund equal to the amount the Fund changed during that month. Change the budget amount of the Income fund to balance the budget. You can set the budget for a fund with 'Change Budget Amount' under the 'Budget' menu. After your spending patterns are fairly clear, you can use the information to set budget goals, and then use the goals to help make decisions about spending.
