TERMS AND CONDITIONS

READ THIS AGREEMENT BEFORE USING THIS COMPUTER LIFE CD-ROM DISK ("CD"). BY USING THE CD YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. The articles and other textual materials from Computer Life, multimedia software and associated documentation and other software and associated documentation, and other materials included on this CD and their compilation, whether on disk, in read only memory or any other media (the "Collection") are licensed to you subject to the terms and conditions of this agreement by Ziff-Davis Publishing Company, having a place of business at One Park Avenue, New York, New York 10016-5802 ("Ziff-Davis").
