Installing The Best Of Girls Will Be Boys

From Windows, use the File Manager to run the SETUP.EXE file on the CD. This will install the The Best Of Girls Will Be Boys program group in the Program Manager with icons for this Read Me, the Best Of Girls Will Be Boys program and the QuickTime 2.0.3 installer. You will need to install QuickTime for Windows before you can run the Best Of Girls Will Be Boys program and if you don't already have version 2.0.3 installed, we strongly recommend installing it from this CD.

Note for Windows 95 Users

To install under Windows 95 you should follow the directions in the Windows 95 manual for installing software rather than directly running the SETUP.EXE and QTINSTALL.EXE files on this CD. If you have problems playing QuickTime movies and you have the CD version of Windows 95 you should see the Read Me file in the QTWFIX directory on the Windows 95 CD which tells how to install software which may improve QuickTime playback performance. The path for this directory is \DRIVERS\OTHER\QTWFIX\.

Recommended Video Settings

Although the Best Of Girls Will Be Boys program runs fine in 8-bit (256 color) mode, it is recommended for the best display of the video portions of the program that you run it with your video card set to 16-bit (65,535 colors) mode.

Minimum Hardware Requirements

- + A personal computer with minimum of a 486sx with a CPU speed of 25MHz
- + VGA video card (SVGA recommended)
- + Minimum of 5 megabytes of conventional and extended memory. (8MB of RAM recommended)
- + A single speed CD-ROM drive (double speed recommended)
- + A hard disk with at least 4 megabytes available for the QuickTime for Windows software
- + Mouse (or other pointing device) supported by Microsoft Windows.
- + A sound card supported by Microsoft Windows

Troubleshooting

Problem: "Can't Load Customer Control DLL":
'D:\QTMOVIE.VBX' Message

+ Reboot System

+ DOS path error. Make sure there is no more than one path for 'C:\QTBIN' Please refer to your DOS manual for editing your Autoexec.bat statement.

+ A Quick Time conflict. More than one version of Quick Time installed (Possibly another CD-ROM movie or an encyclopedia). Remove or rename all older versions of Quick Time on your system. These files start with 'qt' and are located in your windows, windows\system, and QTW directories. Then reinstall the software.

+ If you have Quicken installed on your computer, it creates the file 'quicken.ini', please do not remove this file from the windows directory.

Problem: Program locks up during game play.

+ Commercial screen saver installed, disable screen saver and restart Windows

+ Alternative Desktop (Norton Desktop, PC Tools, etc.), disable and use the Windows Program Manager

+ Low memory, disable all active programs.

Problem: "General Protection Fault Error..." message box

+ Video or Audio driver conflict. Check with the manufacturer for the latest driver

Problem: Scrambled Video Display

+ Conflict with your video Display Card. Edit the file QTW.INI in your WINDOWS directory on your hard drive, change the line:

```
[Video]
Optimize=Hardware
```

to

```
[Video]
Optimize=Driver
           or BMP
           or RAW
           or DIB
```

+ These are in order of priority, if the driver option does not work, then use BMP, RAW or DIB.

+ This problem frequently occurs with Packard Bell System. If the above solution does not work, then call Packard Bell and ask for updated Video Drivers

Problem: Image is difficult to recognize. Only shades of gray and red are visible.

+ Run Windows setup to install the display driver provided by your video card manufacturer that supports 256 colors.

+ Call the manufacturer of your video card and request the most recent version of the video driver.

Problem: Video response is sluggish

+ Switch the video resolution to 640 x 480. You may find that using the ôsmall fontsö driver will

work better than the ôlarge fontsö driver (or vice versa, depending on the video drivers).
+ DOS 6.2 includes a CD cache. Include or edit this line in your config.sys statement:
Device=C:\DOS\Smartdrv.exe /double_buffer
+ Make sure your CD-ROM drive is configured properly. If your CD-ROM is cable of using DMA transfer, make sure it is being utilized
+ Allocate at least 30k to the drive buffer
MSCDEX /d:mscd001 /m:30)
