SURFBOT™ END USER LICENSE AGREEMENT

PLEASE READ THIS LICENSE AGREEMENT BEFORE PROCEEDING WITH THE SETUP AND LOADING OF THE PROGRAM ONTO YOUR COMPUTER. IF YOU DO NOT ACCEPT THE TERMS OF THIS AGREEMENT, DO NOT LOAD THE PROGRAM. INSTEAD, PROMPTLY RETURN THE ENTIRE PACKAGE TO SURFLOGIC LLC FOR A FULL REFUND.

IF YOU ACCEPT THE TERMS OF THIS AGREEMENT, INDICATE YOUR ACCEPTANCE BY CLICKING ON THE APPROPRIATE BOX BELOW AT THE END OF THE AGREEMENT. YOU THEN MAY PROCEED TO LOAD THE PROGRAM ONTO YOUR COMPUTER.

This end user software license agreement (the "Agreement") is entered into between you ("Licensee") and Surflogic LLC ("Licensor"), the owner and creator of Surfbottm.

1. Definitions

The following definitions apply to capitalized terms as they appear in this Agreement:

"Surflogic LLC" means Surflogic Limited Liability Company, the owner and creator of The Program.

"Licensor" means Surflogic LLC.

"You" and "Licensee" mean the person or entity to whom Licensor grants a license to use the Program.

"The Program" means the computer software Internet browsing utility "Surfbot™" and the documentation included with it.

2. License Grant

Licensor grants you a nonexclusive license to: Load the Program onto your computer's storage device and to make additional copies of the Program for your own personal use, provided that you ensure that only one of your copies of the Program is in use on only one computer system at any one time.

3. License Prohibitions

You may not: Remove or alter any of Licensor's copyright notices from any components of the Program; Sublicense, rent or lease all or any part of the Program; Use the Program with the intent to violate any of Licensor's user licensing schemes; Use the Program on more than one computer system at the same time.

4. <u>User Registration Key</u>

Licensor provides you, concurrently with the Program, a single User Registration Key for you to use with the Program. You may use the User Registration Key on more than one computer, but you are to ensure that your copy of the Program is not in use on more than one computer system at any one time.

5. Copyright and Other Restrictions

Surfbot™ is copyrighted with all rights reserved. None of the components of the Program may be copied, removed or altered, in whole or part, for any unauthorized use. You may not disassemble, decompose, reverse engineer, or alter any of the files in the Program. This includes, but is not limited to modifying any icons, menus, or displays associated with the Program.

6. Limited Warranty

If you receive the Program from Licensor on a computer disk or other computer storage device, Licensor warrants the media on which Licensor distributes the Program to you to be free from defects in materials and workmanship for 90 days from your receipt of the Program. Licensor will replace defective media at no charge

to you, provided you return such media to Licensor with 90 days of receiving it. If Licensor is unable to provide a replacement, Licensor will refund the price you paid for The Program.

LICENSOR DISCLAIMS ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING BUT NOT LIMITED TO IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE, WITH RESPECT TO THE PROGRAM.

No Surflogic LLC distributor, dealer, agent, or employee is authorized to make any modification, extension, or addition to this limited warranty.

7. No Liability for Consequential Damages

In no event will Licensor, its licensees, distributors or dealers be liable for direct, incidental or consequential damages, including but not limited to damages resulting from loss of data or business opportunities, resulting from the Program, either alone or in conjunction with other programs.

8. General

This Agreement constitutes the entire Agreement between you and Licensor. It is governed by the laws of the State of California.

9. Restricted Rights And Additional Licenses

If you use Surfbot in a commercial, educational or governmental agency on more than one computer, it is necessary to purchase a SITE LICENSE. The Site License allows the organization to use the Product on up to the number of computers licensed. Site License fees are based on the total number of computers that will use the software package. The Site License package provides a copy of the software with documentation and allows the licensee to copy it for the number of machines licensed. All licenses are prepaid.

Distributing, repackaging, or reselling of the software to third parties is not allowed under either this Agreement or a Site License Agreement. A Distribution License is required by an organization, company or government agency to facilitate the distribution of Surflogic software to outside parties.
