# INWIXCO LICENSE AGREEMENT

## (Registered Software Single User Products)

This is a legal agreement between you (either an individual or an entity) and INWIXCO Inc.

### INWIXCO SOFTWARE LICENSE

1. **GRANT OF LICENSE.** This License Agreement permits you to use one copy of the enclosed INWIXCO software program (the "SOFTWARE") on a single computer. The SOFTWARE is in "use" on a computer when it is loaded into temporary memory (i.e., RAM) or installed into permanent memory (e.g., hard disk, CD-ROM, or other storage device) of that computer. However, installation on a network server for the sole purpose of internal distribution shall not constitute "use" for which a separate license is required, provided you have a separate license for each computer to which the SOFTWARE is distributed.

2. **COPYRIGHT.** The SOFTWARE is owned by INWIXCO is protected by United States copyright laws and international treaty provisions. Therefore, you must treat the SOFTWARE like any other copyrighted material (e.g., a book or musical recording) except that you may either (a) make one copy of the SOFTWARE solely for backup or archival purposes, or (b) transfer the SOFTWARE to a single hard disk provided you keep the original solely for backup or archival purposes. You may not copy the written materials accompanying the SOFTWARE.

**CUSTOMER REMEDIES.** INWIXCO and its suppliers' entire liability and your exclusive remedy shall be, at INWIXCO's option, either (a) return of the price paid, or (b) repair or replacement of the SOFTWARE or hardware that does not meet INWIXCO's Limited Warranty and which is returned to INWIXCO with a copy of your receipt. This Limited Warranty is void if failure of the SOFTWARE or hardware has resulted from accident, abuse, or misapplication. Any replacement SOFTWARE or hardware will be warranted for the remainder of the original warranty period or thirty (30) days, whichever is longer.
