Q'lope Instructions

1. The setup file will copy the following files to your Windows subdirectory

THREED.VBX COMMDLG.DLL VBRUN.DLL (if you don't have it there already) QLOPE.INI QLOPE.HLP

- 2. QLOPE.EXE and this file will be copied to the directory you specify. Normally this will be C:\QLOPE.
- 3. QLOPE is easy to run. The INI file should have the default setups for an HP Laserjet II or III and WYSIWYG Fonts ranging in size from 8 to 14. Check these setting via the Options Menu. The help file contains instructions on setting these options.
- 4. This program left InfoDesign virus free. That does not mean that somewhere in the distribution chain a virus was not introduced.

 Check every software you recieve with a virus scan.
