Description

Web pages let you set certain colors for your web page, the background color (BGCOLOR), text color (TEXT), unvisited link (LINK), active link (ALINK), and visited link (VLINK). HTMLC let's you choose different colors through several different ways for the various color elements in your web page.

When you change the colors for the different elements, you will automatically see them displayed in the Color Display window. This let's you easily try out different color combinations before putting them in your web page.

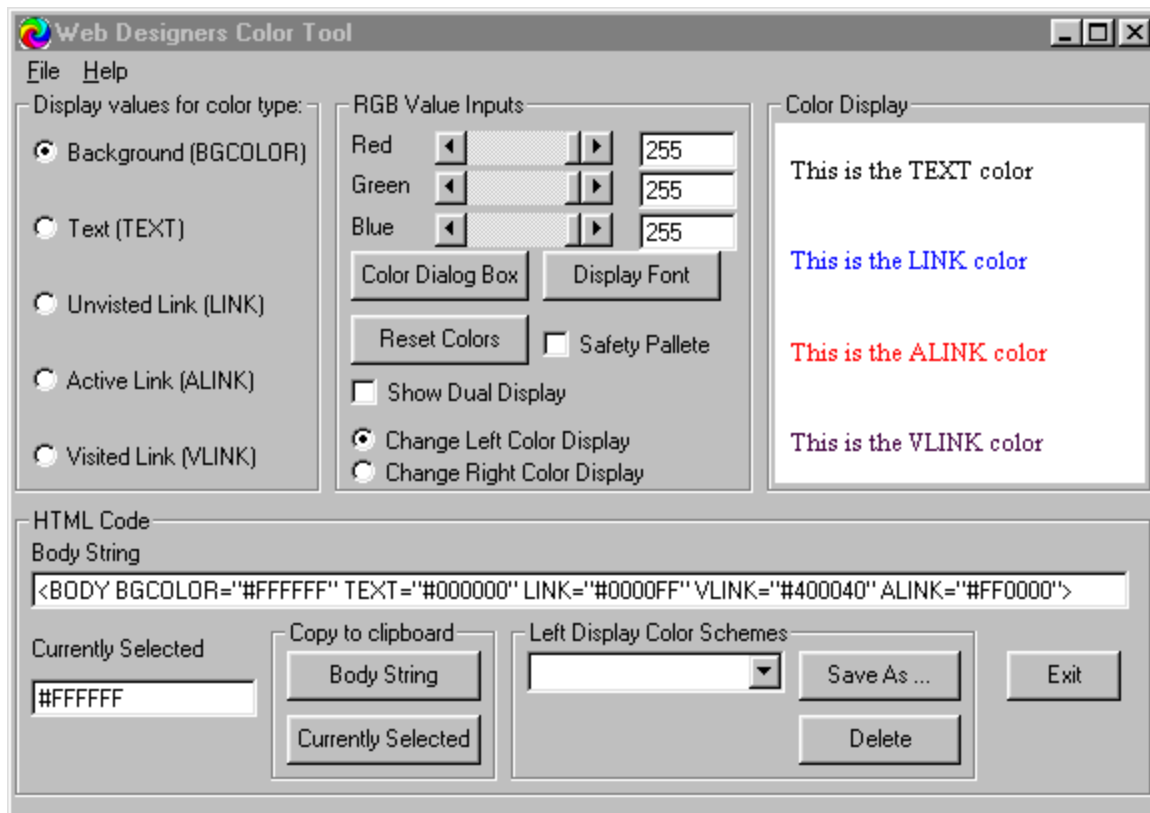

BGCOLOR

When this option is selected, any changes done to the RGB Value Inputs to the right, will be reflected as the background changing color in the Color Display window.

TEXT

When this option is selected, any changes done to the RGB Value Inputs to the right, will be reflected as the "This is the TEXT color" line changing color in the Color Display window.

LINK

When this option is selected, any changes done to the RGB Value Inputs to the right, will be reflected as the "This is the LINK color" line changing color in the Color Display window.

ALINK

When this option is selected, any changes done to the RGB Value Inputs to the right, will be reflected as the "This is the ALINK color" line changing color in the Color Display window.

VLINK

When this option is selected, any changes done to the RGB Value Inputs to the right, will be reflected as the "This is the VLINK color" line changing color in the Color Display window.

Slider Control

Slide the Red, Green and Blue values between 0-255. Changes are displayed in the Color Display window to the right.

RGB Input Box

Input a Red, Green and Blue values between 0-255. Changes are displayed in the Color Display window to the right.

Color Display

All changes to color values and fonts are displayed in this window.

Color Dialog Box

Brings up the Color Dialog Box which let's you select colors from a color palette.

Display Font

Select different font's that will be used for display in the Color Display window.

Reset Colors

Reset all colors to their original values.

Use Safety Palette

Clicking this checkbox will limit the Red, Green, Blue values to ones in the Browser Safety Palette. Using these colors will prevent dithering on 256 color displays.

Body String

Displays the HTML Body String used so your web page will look like the Color Display window.

Currently Selected

Shows the HTML Hex equivalent of the current RGB value for whichever color type (BGCOLOR, TEXT, etc) is selected.

Exit

Exit's the program.

Copy Body String

Copies the value shown in the Body String box to the clipboard.

Copy Currently Selected

Copies the value shown in the Currently Selected box to the clipboard.

Show Dual Display

Brings up second Color Display window

Change Color Display

Select which display window you want to change the colors for

Color Scheme Drop Down

Select previously saved color schemes

Save As ...

Save the current colors for the left Color Display window as a color scheme

Delete

Delete the currently selected Color Scheme
