Definition of Shareware

Shareware distribution gives users a chance to try software before buying it. If you try a Shareware program and continue using it, you are expected to register. Individual programs differ on details -- some request registration while others require it, some specify a maximum trial period. With registration, you get anything from the simple right to continue using the software to an updated program with printed manual.

Copyright laws apply to both Shareware and commercial software, and the copyright holder retains all rights, with a few specific exceptions as stated below. Shareware authors are accomplished programmers, just like commercial authors, and the programs are of comparable quality. (In both cases, there are good programs and bad ones!) The main difference is in the method of distribution. The author specifically grants the right to copy and distribute the software, either to all and sundry or to a specific group. For example, some authors require written permission before a commercial disk vendor may copy their Shareware.

Shareware is a distribution method, not a type of software. You should find software that suits your needs and pocketbook, whether it's commercial or Shareware. The Shareware system makes fitting your needs easier, because you can try before you buy. And because the overhead is low, prices are low also. Shareware has the ultimate money-back guarantee -- if you don't use the product, you don't pay for it.

Trial Period

You have received a FULLY FUNCTIONAL, well-tested and commercially proven product. No essential features have been left out, and you should require nothing additional to use this most powerful tool. Please compare EDGE Diagrammer's power, speed, ease-of-use, and reliability to any and all commercially available diagramming programs! You'll be surprised only at the quality. There will be NO OTHER SURPRISES!

You may try EDGE Diagrammer free of charge for a period of thirty days. During this time, you may use it as often as you like. Load it on as many machines as you like, make as many copies as you like, and PLEASE feel free to help spread EDGE Diagrammer among colleagues and associates. We even encourage you to upload it to Bulletin boards. ALL provided you make no modifications to the files.

After thirty days, your license to legally use EDGE Diagrammer expires and you are expected to register. License

Following are summaries of the software license agreement and the differences between the registered and unregistered versions of the software. Following the summaries is the text of the license. For registered versions, see also the license printed on the disk envelope.

Unregistered version

You are encouraged to pass an unmodified copy of the unregistered version of EDGE Diagrammer along to your friends and colleagues for evaluation. Please encourage them to register their copy if they find that they can use it. All registered users will receive a copy of the latest version of the EDGE Diagrammer system.

Registered version

You must treat the registered version of this software just like a book. An example is that this software may be used by any number of people and may be freely moved from one computer location to another, so long as there is no possibility of it being used at one location while it's being used at another. Just as a book cannot be read by two different persons at the same time. This means that you may NOT install the software on two machines in your workplace without two registered licenses even if only one person will use it simultaneously. You MAY however install it on your personal home machine and your work machine and even your portable provided that no one but you has the ability to use these machines and there is not even a reasonable possibility that two people could use the software.

LIMITED USE SOFTWARE LICENSE AGREEMENT (also in LICENSE.DOC)

IN ANY CASE, PACESTAR SHALL NOT BE LIABLE FOR LOSS OF DATA, LOSS OF PROFITS, LOST SAVINGS, SPECIAL, INCIDENTAL, CONSEQUENTIAL, INDIRECT OR OTHER SIMILAR DAMAGES ARISING FROM BREACH OF WARRANTY, BREACH OF CONTRACT, NEGLIGENCE, OR OTHER LEGAL THEORY EVEN IF PACESTAR OR ITS AGENT HAS BEEN ADVISED OF THE POSSIBILITY OF SUCH DAMAGES, OR FOR ANY CLAIM BY ANY OTHER PARTY. Some jurisdictions do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you.
- General Provisions. Neither this Agreement nor any part or portion hereof shall be assigned or sublicensed, except as described herein. Should any provision of this Agreement be held to be void, invalid, unenforceable or illegal by a court, the validity and enforceability of the other provisions shall not be affected thereby. Failure of a party to enforce any provision of this Agreement shall not constitute or be construed as a waiver of such provision or of the right to enforce such provision.
