2. Make as many copies of the Shareware version of this software and documentation as you wish.
3. Give exact copies of the original Shareware version to anyone.
4. Distribute the Shareware version of the software and documentation in its unmodified form via electronic means.

**QPRO.DLL:** Two separate copies of the Shareware package are usually uploaded to CompuServe, one with the necessary dynamic link library, QPRO.DLL, and one without. Nonetheless, QPRO.DLL is considered to be part of the Shareware version of the software. Regardless of the source, if you wish to redistribute your Shareware version, please be sure to include QPRO.DLL in the package you redistribute.

**Current Price Policy:**
