

INTRODUCTION:

WinVox was designed to fill a gap in the support for the Sound Blaster card under the Windows operating environment. It can record and play .VOC files to/from a disc or record and play files to/from a temporary memory buffer.

INSTALLATION:

Step 1. Copy the **SNDBLST.DLL, VBRUN100.DLL, and WINVOX.WRI** files to your WINDOWS directory.

Step 2. Copy the **WINVOX.EXE** file to a directory of your choice. (The unregistered version must also have the file, **REGISTER.VOC** in the same directory as WINVOX.EXE)

Step 3. Highlight the window in the program manager where you wish the **WinVox** Icon to reside.

Step 3. Select **File, New, Program Item, OK** from the program manager File Menu.

Step 4. Enter the Title of the program in the **description text box**.

Step 5. Enter the full path and filename in the **Command Line text box**.

Step 6. Select **OK**.

Step 7. Double click the Icon to run **WinVox**.

Step 8. Select Help, About WinVox.

Step 9. Check the **SOUND BLASTER SETTINGS**.

Step 10. Check the **Port Address, Interrupt Number** and **DMA** settings.

Step 11. If any of the settings are zero you must add the following lines to the **WIN.INI** file:

[SoundBlaster] Port=220 Int=7 DMA=1

Then, exit and re-start windows for the changes to take effect.

Note: These are the **default** settings as specified in the Sound Blaster manual. <u>If you have changed any of these settings, the entries to the</u> **WIN.INI** file should be changed accordingly.

COMMANDS:

Open:	Plays the Currently selected file.
Delete:	Deletes the currently selected file.
Set Default Directory:	The current drive and directory will be set as
the	startup directory the next time WinVox is
run.	
Exit:	Ends the program.
HELP MENU:

Help On Help: instructions on how to use help. Activates a message box with a plea to help WinVox Help: registering your copy of WinVox. If this me by program is a success, a new version with a real help file will be released. WinVox Text: Activates MS Write with the file you are reading. About WinVox: Displays an "About Box" that supplies a little more

information than most "About Boxes" do.

BUTTONS:

Rec File: Activates a dialog box allowing you to enter a filename to record to. After selecting recording process will begin. "OK" the Plays the currently selected file. Play File: Rec Mem: Records to a temporary memory buffer. Plays the contents of a temporary memory Play Mem: buffer. Stop: Stops the currently active process. Pause (Continue): Pauses the currently active process. The caption then changes to Continue. button's Continue (Pause): Continues the currently paused process. The

Clear Mem: Exit:	button's caption then changes to Pause. Releases memory allocated for the temporary memory buffer. Ends the program.
OTHER CONTROLS: Status Line:	Above the buttons, there is a status line that shows various information about the
program. Show Options: Rate	Enlarges the window to show the Sampling and Buffer Size scroll bars.
Sampling Rate:	Use this scroll bar to increase/decrease the sampling rate. This sampling rate
applies to both	recording and playback of the

temporary memory buffer and to recording files. (Not playback of files.) The sampling the program is rate defaults to 8KHz when started Buffer Size: Controls the size of the temporary memory If there is not enough memory buffer. requested, available for the the amount buffer program will crash. The size defaults to 64KBytes when the program is started.

This program is totally and absolutely **INCOMPATIBLE with After Dark for Windows.** Be Sure to turn After Dark **OFF** before using this program.

NOTES:

Since this program is written in Visual Basic, and SNDBLST.DLL is written for "C" programs. I had to do some things that are not exactly supported by the Visual Basic language. During the development of this program, the program caused my machine to re-boot an uncounted number of times. I have de-bugged the software to the point where I don't think this will happen. If it does, please let me know what was going on just before it crashed. I am always in the process of improving my software, and any information will help.

When another program is performing an operation that takes over the CPU for a long time (i.e. disc access or major screen refreshes) the current voice process will stop. It will continue when the other program releases control of the CPU. This is a limitation of Creative Lab's DLL and the Windows environment, not this software.

PLANNED ENHANCEMENTS:

1. A queued file playing system like Creative Lab's Jukebox for Windows.

2. Support for playing .MID files as well as .VOC files.

3. A ultra-simplified .VOC player using a command line parameter to play a

single file of your choice.

- 5. Playing files at a specified time.
- 6. .VOC file editing.

7. A more graceful recovery from an insuffucient memory error.
